

The meeting for technical proposals for the procurement of sewing machines, shallow and deep hand pumps were held on 26th January, 2015 under the Chairmanship of Secretary, Auqaf, Religious Affairs, Zakat & Ushr Department, Government of Sindh in his office. The following members were present.

The worthy Secretary, Auqaf, Religious Affairs, Zakat & Ushr Department/Chairman of Procurement Committee welcomed the participants and desired to sign the attendance sheets. The Procurement Committee and the parties/firms/contractors or their representatives have signed the "Attendance Sheets".

After that, in light of SPPRA Rules 2010 (amended 2013) Rule 41, the Procurement Committee opened the sealed "Technical Proposals" in presence of the parties/firms/contractors or their representatives. The technical proposals were evaluated in light of SPPRA Rules 2010 (amended 2013) Rules 46(2) i.e. "Single Stage - Two Envelops", as mentioned in the Notice Inviting Tender.

OBSERVATIONS/FINDINGS OF COMMITTEE FOR TECHNICAL PROPOSALS:

SEWING MACHINES:

- ▶ Three parties / firms /suppliers viz: (1) M/s. Awaad Enterprises, (2) M/s W.S Enterprises and (3) M/s Sindh Traders, applied for and submitted technical proposals.
- ▶ As per NIT in order to evaluate the proposals, the required documents were checked and found that two parties/firms/suppliers as at sr.no.2 & 3 above have qualified whereas the party /supplier as at sr.no.1 has disqualified as they earned 51.6% marks and not eligible for opening of their "Financial Proposal", therefore, in light of PPRA Rules 2010 (amended 2013) Rule 46 (2) (h) the "Financial Proposal" has been returned to them unopened.

SHALLOW HAND PUMPS:


- ▶ Two parties / firms /suppliers viz: (1) M/s. Awaad Enterprises and (2) M/s W.S Enterprises applied for and submitted technical proposals.
- ▶ As per NIT in order to evaluate the proposals, the required documents were checked and found that the party/firm/supplier as at sr.no.2 above has qualified whereas the second party /supplier as at sr.no.1 has earned only 51.6% and dis-qualified, therefore, in light of PPRA Rules 2010 (amended 2013) Rule 46 (2) (h) the "Financial Proposal" has been returned to them unopened.


DEEP HAND PUMPS:


- ▶ Two parties / firms /suppliers viz: (1) M/s. Awaad Enterprises and (2) M/s W.S Enterprises applied for and submitted technical proposals.
- ▶ Similar position was observed as found in the technical proposals for shallow hand pumps. M/s. Awaad Enterprises earned 46.6% marks and not eligible for opening of their "Financial Proposal", therefore, in light of PPRA Rules 2010 (amended 2013) Rule 46 (2) (h) the "Financial Proposal" has been returned to them unopened.

- ▶ After getting verification of rates, necessary approval from the competent authority may be obtained for awarding of work to the bidder for providing of shallow hand pump including installation.

- ▶ The boring rate for Shallow Hand Pump is Rs. 70/- to Rs.90/- per feet approximately & construction plate form is between Rs.4000/- to Rs.6000/-, thus the cost of boring up to 50 feet comes to Rs.3500/- to Rs.4500/-.
