Further, while comparing the bids with the estimated cost, it is observed that the first lowest bidder namely M/s Gul Traders has quoted his bid lower than the estimated cost by 0.49% whereas, remaining two bidders namely M/s Muhammad Najeeb & Sons and M/s Sun Green Electric & Construction Co, have quoted their bids higher than the estimated cost by 2.90% and 7.12% respectively.

Conclusion / Recommendations:

- We are of the opinion that since tendered cost of M/s Gul Traders who are the 1st lowest is workable and lower than the estimated cost of the work. Therefore, it is recommended that the subject work to be awarded to him.
- The work order to be issued to contractor M/s Gul Traders as per following details:
 - The contractor shall not be paid any escalation or difference of material on any item as the work comprises on Market Rate Items only.
 - · The contractor has offered no rebate.
 - The contractor shall not be paid any cartage separately.
 - The contractor to submit Construction Schedule within seven days of the issuance of work order.
