

(a) Genome Analyzer

Five quotations were received. Price quoted by M/S EMS Technologies was lowest, however it does not fulfill the technical specifications mentioned in the tender document.

The second quote was from M/S Unitrade. The instrument fulfills all requirements of technical specifications. Moreover, running cost of this equipment is 40% less compared to others.. The manufacturer has also agreed to provide application and engineer level training for one month in their facility.

The committee there fore recommends purchase of the same from M/S Unitrade.

(b) Bioanalyzer.

Three quotations were received. The price quoted by M/S H.S.Shah & Sons was the lowest and fulfilling the technical specifications mentioned in the tender document and therefore recommended for purchase.
