Our Consulate security team has visited the proposed SBEP PMIU office venue and has indicated that they would <u>not</u> recommend selecting this option. The concerns are the following: The building is too close to a main road with no egress space between the road and the building, the parking space is not secured, too much exposed glass on the side of the building where the main road is thus potentially exposing employees to injury if there were any blasts.Â

If you choose to move forward, no American officer would be allowed to visit the premise so you will need to keep this in mind as you move forward in selecting a new office site.

Minutes of 61st Procurement Committee Meeting of (PMIU-SBEP)

Attendance Sheet is attached.

Proceedings & Decision:

M/s Halcrow Pakistan presented the following Tender Documents to the Procurement Committee:

Tender Documents of Package 13A and Package 13B (construction of 13 schools in District Jacobabad (Taluka Garhi Khairo, Jacobabad & Thull) and Package 14A and Package 14B (construction of 10 schools in District Kashmore (Taluka Tangwani, Kandhkot and Kashmore for approval.

The Procurement Committee after review approved the Tender Documents for schools in Kashmore & Jacobabad of Package 13A & Package 13B and Package 14A & Package 14B with slightly changes in evaluation criteria. For instance marking weightage in experience record in Para 2.1, 2.2 & 2.4 has been changed to ensure that no any contractor without appropriate building work experience qualifies.

More clarity is given to evaluation criterion by inserting" documents required & "notes". Under Para 3.1 for Personal Capabilities, evidence of engagement by letter of commitment from at least 02 graduate engineers is now required for specific position of project manager & planning engineers.

Bid Evaluation Reports of the following Tenders for approval:

- Construction of eight schools in District Qambershahdadkot [Package 11, (Rebid)]
- Construction of five schools in Karachi [Package 5A (Balance work, Karachi)].

The Procurement Committee reviewed and analyzed the Bid Evaluation Report of Package 11 (QSK-II) and found that the first lowest evaluated Bidder i.e. M/s Friends Enterprises is 7.45% less than the engineer's estimate. Therefore the Committee approved the BER of [Package 11, (Qambershahdadkot)].

The Procurement Committee reviewed and analyzed the Bid Evaluation Report of Package 5A (balance work, Karachi). The Committee observed that the first lowest Bidder i.e. M/s WSKB & Company were technically disqualified. However, the bid amount of the 2nd lowest Bidder i.e. M/s Friends Enterprise was 10.92% higher than the engineer's estimate. Therefore, the Committee did not approve the Bid Evaluation Report of [Package 5A (balance work, Karachi)] and decided to publish a fresh NIT in national newspapers (re-tender) with same bidding documents.

III. The Procurement Officer (PMIU-SBEP) presented the Bid Evaluation Report of the following Tender:

Acquiring armed security services for five under construction schools sites in Karachi.

The Procurement Committee did not approve the Bid Evaluation Report of single bid received for "Acquiring armed security services for five under construction schools sites in Karachi" as per month security service charges were more than the security services already hired on contingency basis through School Management Committees under SBEP Community Mobilization Program. Second because of community stakes in the Project, it was decided to continue services of same security staff on contingency basis staff for another one-two months.

IV. Bid Opening of "Acquiring Office Premises on rental Basis".

Two bids were received and were opened in the presence of the Procurement Committee and one representative of bidder.

The Committee shall present outcome of result in the next meeting after evaluating the bids.

Bids of acquiring Internet Services for PMIU-SBEP were opened V.

Three bids were received and were opened in the presence of the Procurement Committee and representatives of bidders.

The bid from M/s Augere Pakistan (Pvt) Ltd was found lowest read out price; the Committee shall present outcome of result in the next meeting after evaluating the bid. Bid opening sheet annexed at C.
