
The meeting started with the name of Allah the almighty. The Chairman Procurement Committee welcomed the participants of the meeting and opened the discussion on agenda items.



It was further decided in the meeting that:

- The fertilizers should be purchased on the current rates declared by the manufacturers / importers through print media on the date of procurement.
- It should be ensured that items to be purchased shall be of specific quality from reputed firms not beyond the market rates.
- All the firms will pay the income tax, GST and all other usual taxes (payable under rules) from the approved cost.
- The payment shall be made to the firms against the supply of the items subject to the inspection report ensuring that items are according to the specification.
- All the firms will be responsible to deliver the goods at their own expenses within thirty (30) days after issuance of the supply order, failing which their supply orders will be




treated as cancelled and same will be issued to 2nd lowest bidder (subject to qualifying technical specifications).







