This is with reference to above letter, it is to inform you that as per Rule-20 (1) of SPPRA Rules 2010 (amended 2013) the bidding documents were available to all the interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tenders and as per Rule-18 (3) the bidding documents were available for sale to all the interested bidders from the first day of publication of Notice Inviting Tenders hoisting on the authority's website further as per Rule-4 the authority of DMC (East) while procuring works is ensured that the procurement is to be conducted in a fair and transparent manner and there is no restriction for the contractors regarding issuing of tenders.

In view of above the complainant did not apply for purchase of tenders and there is no any documentary proof attached along with his complaint regarding receiving of application and pay orders of tender cost in this office.

As far as non issuance of tender documents to the complainant it is clarified that this office also hoisted all the bidding documents along with tender Schedules / Bill of Quantities on the SPPRA website from the 1st day of publication of NIT at SPPRA Serial No.31547 further as per Clause-12 of the Tender Notice the tenders can be downloaded from the SPPRA website and can be submitted with tender fees by mail or by hand but complainant deliberately not downloaded the bidding documents from the SPPRA website to stop whole the transparent procedure which is in accordance with SPPRA Rules further the tender Box kept in committee room and all the tenders were opened in the presence of contractors and their authorized representatives (copy of attendance sheet as evidence is enclosed) so no favoritism is given to any contractor and all the works are evaluated as per minimum qualification and eligibility criteria mentioned in the NIT by the tender / procurement opening committee of D.M.C. (East).

In view of above facts the allegations of the complainant are not correct as well as fake, false and malafied so kindly dropped his complaint.
