

# MINUTES OF THE MEETING

FOR

## "PURCHASE OF MEDICAL EQUIPMENTS / MACHINERY FOR SHAHEED MOHTARMA BENAZIR BHUTTO CARDIAC CARE HOSPITAL TANDO MUHAMMAD KHAN (SMBBCCH-TMK)"

### 1. INVITATION TO BIDDERS

Tenders under sealed cover for "PURCHASE OF MEDICAL EQUIPMENTS / MACHINERY FOR SHAHEED MOHTARMA BENAZIR BHUTTO CARDIAC CARE HOSPITAL TANDO MUHAMMAD KHAN (SMBBCCH-TMK)" were invited from the contractors / firms. The invitation to Bid issued to the Bidders suggest the procurement through open competitive bidding to be processed under single stage-two envelope methodology.

Tender notice was published in leading newspapers Viz. Daily The Dawn, Dunya and Kawish newspapers dated 26<sup>th</sup> Nov 2016, 27<sup>th</sup> Nov 2016 and 29<sup>th</sup> Nov 2016 respectively. The same were also uploaded on SPPRA's website on 2<sup>nd</sup> Dec 2016. The tender opening date was set to be 19<sup>th</sup> Dec 2016 at 01:30pm in the office of Deputy Commissioner-Tando Muhammad Khan.

As per provided Evaluation criteria in Bidding Documents, the participating firms/companies were required to furnish following information in the Technical Proposal.

1. Copy of NTN Certificate and Sales Tax Certificate
2. Copy of ISO Certificate of bidding firm.
3. Satisfactory Certificates/Letters from previous users
4. Financial Turn Over of last 3 years (Bank statement or Current Bank Certificate)
5. Undertaking affidavit that the firm has never been black listed by any agency or in litigation with any agency.

### 2. SUBMISSION OF BIDS

In response to advertisement following fourteen (14) bidders purchased the Tender Documents and only Eight (08) bidders submitted their Technical and Financial Proposals as per the required format of separate envelope for Technical and Financial proposals. These eight firms are;

1. Technology Links Pvt Ltd
2. Feroz Sons
3. Shirazi Trading Company Pvt Ltd
4. Iqbal & Company
5. Universal Enterprises
6. Medequips S.M.C.
7. Radiant Medical Pvt Ltd
8. Med-Elec Corporation

The Technical proposals of above mentioned bidders were opened publicly in presence of the Members of Procurement Committee, Project Consultants and respective representatives of bidders, on the prescribed date & time of bid opening (19th Dec 2016 at 01:30pm).



The technical evaluation was made purely on the basis of information given in the documents submitted by the bidders as per Evaluation Criteria.

### 3. MANDATORY REQUIREMENTS

Following are the mandatory requirements that each Firm / Contractor has to meet in order to be considered for qualification.

- i. The firms must quote their latest and leading brands from the origins mentioned in each equipment with the proven past performance nationally and internationally. The firm must possess its related back-up support services including trained engineers, workshop facilities, spare parts availability and repair/calibration tools etc.
- ii. The quoting firm must possess ISO 9000 certificate for after sales service delivery and should have proper infrastructure to handle and execute the complete package with previous experience. Copy of valid ISO 9000 certificate must be attached.
- iii. The quoting firm must have installed at least 5-Units of same equipment in Pakistan and must bring satisfactory recommendation letters from at least 5 local users along with installation certificates.
- iv. The firm must be a sole distributor at least for the five consecutive years and also must have an established track record of government supplies of over 5-years.
- v. The most important criterion is the capability to provide quick and efficient after sales service at site. The hospital reserves the right to inspect workshop facilities of the vendor at any time to ascertain technical delivery capability. Bidders with inadequate facilities will not be considered.
- vi. The preference will be given to those firms who quote a complete package and offer a package price for entire items. However a firm can also quote on individual items as well.

The five (05) qualified firms were intimidated vide letter no. DC/PSDC/SMBBC CHTMK/134/2017 dated 02-02-2017 to attend and participate in the Financial Bid Opening which was fixed on 6th Feb 2017.

The Financial Bid of qualified firms were opened in Office of Deputy Commissioner Tando Muhammad Khan on 6th Feb 2017 at 12:00 noon in presence of members of Procurement Committee and representatives of participating Bidders. The item wise original quoted rates were read a loud during opening.

It was noted that only Two (02) firms quoted their bid on complete Package basis as preferred by the procuring agency.

## Final Evaluation of Bio- Medical Equipment Tender of Shaheed Mohtarma Benazir Bhutto Cardiac Care Hospital, TANDO MUHAMMAD KHAN.

After the completion of tendering process of technical and financial; committees have preferred those companies who has participated with complete package as per tender terms published in Newspaper.

Two companies has participated with complete package i.e., M/s Universal Enterprises and M/s Medequips S.M.C.

During the technical evaluation of the above mentioned companies, we have observed some major deviations in the specifications of items quoted by Universal enterprises; whereas Medequips equipment are as per specifications.

M/S Medequips is approved on the basis of the following reasons:

1. Almost all the items quoted from M/s Medequips are found as per specifications as per tender. (Technical evaluation report with details have been attached).
2. M/S Medequips is the sole distributor of Toshiba (Japan) since last many years. This is very old company with strong backup support i.e., technical team/biomedical engineers). In Cardiac setup Angiography machine is the main machine on which whole operations of invasive procedures depends and M/S Medequips is the brand leader in Pakistan and has installed angiography machines allover the Pakistan. At NICVD they have installed 7 Angiography machines and till to-date the downtime is ZERO.
3. M/S Universal is not the sole distributor of any angiography machine. They have quoted Angiography machine of M/S Siemens.
4. Operating cost/annual maintenance cost not mentioned in the technical offer required as per clause 28.2 (iii) on page 12 by any bidder except medequips which is mandatory.
5. Functional guarantee of the proposed goods not mentioned in technical specs as per tender clause 28.2(iv) on page 12 by any bidder except medequips which is mandatory.

## “PURCHASE OF FURNITURE AND ELECTRICAL APPLIANCES FOR SHAHEED MUHTARMA BENAZIR BHUTTO CARDIAC CARE HOSPITAL TANDO MUHAMMAD KHAN”

Further, while comparing the bids with the estimated cost, it is observed that the first lowest bidder namely M/s Yaseen & Company has quoted his bid higher than the estimated cost by 12.87% whereas, second bidder namely M/s G. Sarwar Enterprises has quoted his bid much higher than the estimated cost by 22.90%.

### Conclusion / Recommendations:

1. Since M/s Yaseen & Company is the 1<sup>st</sup> lowest and his quoted rates responsive and workable. Therefore, it is recommended that the subject work to be awarded to him.
2. The work order to be issued to contractor as per following details:
  - The contractor shall not be paid any escalation or difference of material on any item.
  - The contractor shall not be paid any cartage separately.
  - The contractor to submit Construction Schedule within 7 days after issuance of work order.


