MINUTES OF MEETING OF PROCUREMENT COMMITTEE HELD ON 4-02-2015 AT 1:00PM IN THE OFFICE OF THE EXECUTIVE ENGINEER HPCD-II, 1ST FLOOR, H.D.A BUILDING QASIMABAD. HYDERABAD.

The meeting of procurement committee held on 4-02-2015 at 1:00pm to open the sealed tenders which were invited by the Executive Engineer HPCD-II, vide NIT No. EE/HPCD-II/HDA/814, Dated:19/01/2015, on SBD on the bases of Single stage one envelope, for procurement of below mentioned works. The NIT was published in print media under No. INF/KRY/ 188/2015 and was also hoisted with SBD on PPRA Sindh website at S.#22463, dated, 20/01/2015. The photostate copies of published NIT in News papers, Notification of procurement committee and Annual procurement plan for the year 2014-2015 was sent to your authority under letter. No. EE/HPCD-II/HDA/822, Dated:21/01/2015. The tenders were opened by procurement committee in presence of bidders/ representative on 04/02/2015 at 1:00pm in the office of the Executive Engineer, Housing Project Constt; Division-II, First floor, HDA building, Qasimabad as under.

During the premilinary screening of the documents produced by M/s Orient Engineering works at the time of issuance of bidding documents were examined and found that the contractor has provided in-valid license of Pakistan Engineering Council, having validity up till 31st December 2014, besides this he has also not produced the registeration with Sindh Revenue Board which were mandatory for bidding as per provision of SPP rule-46-III and (ammendment 2013), as mentioned in eligibity creteria of published NIT, as well as clause IB-2(a) of standard bidding documents. The Executive Engineer, Housing Project Constt: Division-II, HDA under letter No. EE/HPCD-II/HDA/841, Dated:26/01/2015, has requested the bidder to provide the valid license of PEC and registeration with SRB on or before 04/02/2015, with a copy along with enclosure was sent to SPPRA, but the firm again submitted the same in-valid PEC license having validity upto 31st December, 2014 with a remarks that the license is valid for renewal up till 31st March 2015, and further stated that a copy of registeration with SRB attached, vide his application dated 28/01/2015, but the copy of registeration with SRB was not found attached with above application.

Upon this state of affairs the Executive Engineer, Housing Project Constt: Division-II, HDA, under letter No. EE/HPCD-II/HDA/866, Dated:06/02/2015, informed the contractor about the factual position and requested him to provide a copy of the registeration with SRB, but not responded till date.

As the contractor is non serious and trying to mis-lead the procurement agency just to sabotage the transparent process of procurement by way of mis-quoting.

As M/s Orient Engineering Works stood 1st in the ranking for the work at serial No.1 above, but not furnished the valid lisence of PEC for the year 2015 and registeration with SRB as per provision of SPP rule-46-III and (ammendment 2013), and

clause IB2,(a) of SBD. Beside this the Contractor also failed to furnish the evidance of qualification to perform the contract with bidding documents as per provision of clause IB-2(c), IB-11 persuant to clause IB-8 of SBD as mentioned in published NIT. Hence M/s Orient Engineering Works is declared as in-eligible for bidding and un-qualified to perform the contract. In the light of above mentioned facts M/s Orient Engineering Works stands dis-qualified in non compliance of SPP rule 46-III of 2010 (ammendment 2013) and SPP rule-42 of 2010 read with clause 7-6 (A-1) and i (1-AB) of regulation of procurement of works 2013, and clause IB-11 persuant to clause IB-8 of SBD.

The documents of M/s Jiando Khan who stood 2nd lowest in ranking of work at serial No.1 were examined and found that the contractor is eligible and qualified for award of contract of the work as per provision of SPP Rule 46-III of 2010 (ammendment 2013) and clause IB-11 of SBD

The procurement committee recommends to award both the works as mentioned above, to M/s Jiando Khan as per provision of SPP rules 2010 and regulations 2013.
