The purchase Committee has to discuss the purchase of Veterinary Medicines and Vaccines for office of the Deputy Director Livestock/Animal Husbandry Shikarpur, for the year 2014-2015 from the regular budgetary provisions on the recommendations of Technical/Standardization Committee.

**Summary:**

1. Requirement pertains to: Deputy Director Livestock/Animal Husbandry Shikarpur.



Procurement of Veterinary Medicines for office of the Deputy Director Livestock/Animal Husbandry Shikarpur, during the year 2014-2015.

Deputy Director Livestock / Animal Husbandry Shikarpur informed the forum that tenders were called through Newspapers for purchase of above items against the allocation of Rs: 2.833 million, provided under Regular Budgetary Provisions during the current financial year 2014-2015, Tenders appeared in Newspapers on 18<sup>th</sup>, 19<sup>th</sup> & 20<sup>th</sup> September 2014 and were purchased by 04 firms. Three firms responded and provided the relevant / required documents like Income Tax, Professional Tax, GST Certificates, authority letter and registration of item with Ministry of Health Government of Pakistan.

The tender were opened by the Technical / Standardization Committee on 21-10-2014 and scrutinized by the Technical Committee in its 2<sup>nd</sup> & 3<sup>rd</sup> meeting held on 12-11-2014 & 20-11-2014. Accordingly comparative statement prepared and placed before the purchase Committee.

**It was further decided in the meeting that:**

All the vaccines should be purchased from the Government Institutes on need basis.


The items (except herbal in nature) for which no any firm quoted the rates and are essentially required for the field activities are allowed to be purchased through quotations on competitive rates.

- ❖ The firms quoted the rates for any items as an equivalent without mentioning the name of product / item to be supplied as equivalent will not be considered; only those items will be considered as an equivalent in which the name of product / item has been indicated.
- ❖ The firms shall provide minimum one year shelf life of medicines.
- ❖ It should be ensured that items to be purchased shall be of specific quality from reputed firms not beyond the market rates.
- ❖ All the firms will pay G.S.T. (payable under rules) from the approved cost.
- ❖ All the firms will have to pay income tax and all other usual taxes payable rules.
- ❖ The Payment shall be made to the firms against the supply of the items subject to the inspection report ensuring that items are accordingly to the specification.
- ❖ All the firms will be responsible to deliver the goods at their own expenses within thirty (30) days after issuance of the supply order, failing which their supply orders will be treated as cancelled and same will be issued to 2<sup>nd</sup> lowest bidder (subject to qualifying technical specifications).
