

The meeting stated as per schedule, Director General Livestock Sindh Hyderabad, Livestock and Fisheries Department welcomed the participants of the meeting and opened the discussion on agenda items for:-

Procurement of Veterinary Medicines for office of the Deputy Director Livestock/Animal Husbandry Shikarpur, during the year 2014-2015.

Deputy Director Livestock / Animal Husbandry Shikarpur informed the forum that tenders were called through Newspapers for purchase of above items against the allocation of Rs: 2.833 million, provided under Regular Budgetary Provisions during the current financial year 2014-2015, Tenders appeared in Newspapers on 18th, 19th & 20th September 2014 and were purchased by 04 firms. Three firms responded and provided the relevant / required documents like Income Tax, Professional Tax, GST Certificates, authority letter and registration of item with Ministry of Health Government of Pakistan.

The tender were opened by the Technical / Standardization Committee on 21-10-2014 and scrutinized by the Technical Committee in its 2nd & 3rd meeting held on 12-11-2014 & 20-11-2014. Accordingly comparative statement prepared and placed before the purchase Committee.

In the light of recommendations of Procurement Committee and justification provided by the Deputy Director Livestock / Animal Husbandry Shikarpur the purchase Committee decided that:

Items for which three or more than three firms participated in the tendering; the
purchase Committee approved the procurement from 1st lowest firm after
observing quality plus standard condition and durability of the items.
