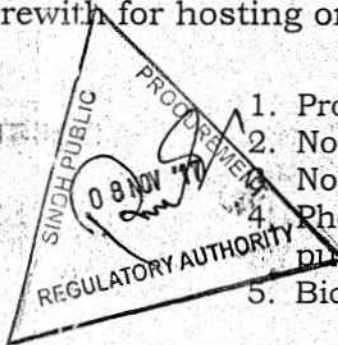

As per the terms and condition of financial bid submitted by bidders, a comparative statement of quoted/non-quoted items prepared and evaluated by the committee, as per bid document, the lowest quoted item were approved and bidders are bound to supply the Medicines in accordance with Bid document as per PPRA Rules.

During the evaluation of Financial Bid and expert opinion taken from the consultant on their opinion and suggestions 2<sup>nd</sup>, 3<sup>rd</sup> lowest products are also selected because of best quality products/Drug items for the benefit of patients.


The Procurement Committee agreed and recommended to issue supply orders to the bidders having lowest rates and selected items as per consultant opinions.
