- The Procurement Committee with mutual consent decided that as only one Kit is needed to be procured & only three bids are received so in order to save time & to ensure transparency the bids were evaluated in presence of bidders as the procurement officer announced all the documents attached with the bids as required in the bidding documents for evaluation & announced the bidders who qualified for evaluation in terms of quoted rates.
- 10. All bids were signed by the members of Procurement Committee accordingly.
- 11. After thorough evaluation following bidder was found responsive & the procurement committee recommended the same for award of contract.

- 12. The Chairman Procurement Committee intimated the qualified bidder for award of contract that the offer letter will be issued after completion of hoisting timeframe in compliance of SPP Rules 2010 (amended 2013).
