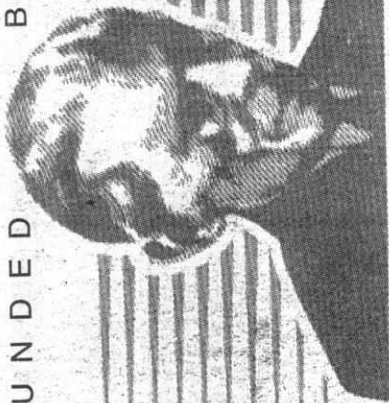

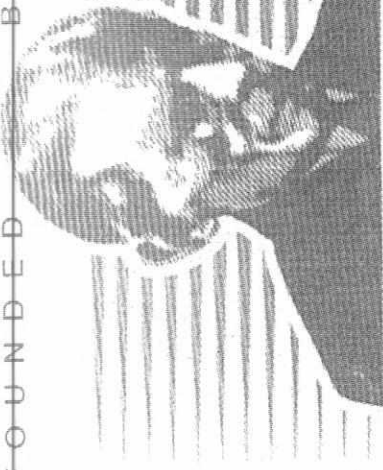

KOLKATA: West Indies' Carlos Brathwaite hit England's Ben Stokes for four successive sixes to snatch a thrilling four-wicket win in Sunday's World Twenty20 final as the Caribbean side became the first team to win the title twice.

Darren Sammy's men made a grand double for the Caribbean cricket after Hayley Matthews and Stafanie Taylor figured in a record partnership earlier in the day to help the West Indies defeat Australia by eight wickets and clinch their maiden title at the women's World Twenty20.




