



BACKGROUND:

The IFB for hiring of consultancy firm through QCBS method was floated through Advertisement in press on 10th October 2017 and SPPRA Web site. In response, 02 firms submitted their technical and financial proposals. The technical proposals of both the firms were opened on due date i.e. 30th October 2017 at 12.30, whereas financial proposals were kept sealed. On 06th December 2017, the meeting of Consultant Selection Committee was held, wherein technical proposals of both firms were evaluated. After detailed deliberation, the Consultant Selection Committee declared the proposal of M/s IBA Sukkur as technically approved, whereas the technical proposal of M/s AZ Corp Entertainment stood technically rejected. Score obtained by both the firms is hereunder.

M/s IBA Sukkur

= 87 marks

M/s AZ Corp Entertainment = 42 marks.

The above results were communicated to the firm accordingly. Schedule for opening of financial proposals was fixed as on 12th December 2017 at 11.30 AM at RSU. The technically approved firm M/s IBA Sukkur and the members of Consultant Selection Committee were informed accordingly.



Meeting Proceedings

With the permission of Consultant Selection Committee, Senior Program Manager (Procurement)-RSU opened the financial proposal of technically accepted firm M/s IBA Sukkur. The prices quoted by M/s IBA Sukkur was PKR 145,591,000/- inclusive of taxes. Consultant Selection Committee recommended M/s IBA Sukkur for further process / contract.
