14/- Committee evaluated the Technical proposals of Hand Cuffs according to evaluation criteria given in the Bid Document. The Committee unanimously approved the procurement of Hand Cuffs Model M-11-1 (Korea) for Sindh Police due to following reasons:-

- i) Consist of double groves.
- ii) Locking mechanism is complex and difficult to open.
- iii) Mobility of Hands is restricted as compare to other Hand Cuffs.
- iv) In this regard Committee hired the services of Key Maker Mr. Samiullah (Mobile No.0306-2506748) by local market. All the samples of Hand Cuffs were put up before the Key Maker and asked him to open the lock of Hand Cuffs by his experience. The key maker opened the lock of Hand Cuffs (mentioned at para-13 at serial No. 1 to 6) but failed to open the lock of Hand Cuffs model M-11-1 Korea (indicated at serial No.7) offered by M/s Sana International Trading Corporation.

15/- On 27.08.2013 Financial Proposals of the qualified firm was opened before the representative of participated firm. Its result is as under:-

2/- The follow firms, who had participated in the process of procurement of Hand Cuffs for Sindh Police lodged complaints:-


- a. M/s Ahmed Traders






