The Chair welcomed the participant and opened the discussion on agenda items.




DECISIONS:

After detailed discussions following decisions were taken:

1. Approved the rates of Rs: 9780/= per kit quoted by M/s: Toor Industries Sialkot being lowest as mentioned above.

2. Project Director , BBSYDP, Livestock & Fisheries Department Hyderabad to issue supply order to the M/s: Toor Industries Sialkot being successful lowest/responsive bidder on the approved rates after observing all codal formalities including execution of contract agreement on stamp paper prior to issuance of supply orders as per SPPRA rules.
3. The firm will submit the performance security of 10% of total cost of contract agreement in shape of pay order/demand draft prior to issuance of supply order as per SPPRA rules 2010 (Ammended-2013).
4. The firm will pay the income Tax/GST/SRB and other usual taxes as per Government Policy.
5. The payment shall be made to the firms against the supply of items subject to the inspection by the sub-committee constituted by the Project Director, BBSYDP, Livestock & Fisheries Department Hyderabad and ensure items are supplied according to the specifications.
6. M/s: Toor Industries Sialkot will be responsible to deliver the goods at their own expenses within 30 days after issuance of the supply orders, failing which their supply order will be treated as cancelled.
