The Underground Coal Gasification Thar Project, Energy Department, Government of Sindh, invited sealed tender from reputed suppliers / firms registered with income tax/sales tax department for "Supply of Structural Material" through limited tender No. UCG/Mech-236 /2015 hoisted at SPPRA Website vide Sr. #23174 dated 11th March, 2015.

2. The tender documents were purchased by Four suppliers / firms as per detail given below: -

- b) M/s T.M Anjarwal & Sons Karachi
- c) M/s Al- Faisal Karachi.
- d) M/s Jagani & Brothers Mithi

3. Following suppliers / firms submitted their tender documents / bids one hour before opening time i.e. on 26th March 2015 at 1100 hours: -

- c) M/s Al- Faisal Karachi.
- d) M/s Jagani & Brothers Mithi

4. The Bids submitted by the firms were opened publicly on 26th March 2015 at 1200 Hours in the presence of the Procurement Committee and the participant bidders M/s H. Abdul Ali Sons Karachi, M/s T.M Anjarwal & Sons Karachi, M/s Al- Faisal Karachi & M/s Jagani & Brothers Mithi, did not participate in the Tender Opening (Attendance Sheet is attached). The evaluation of the bids was carried out in the light of Eligibility Criteria, Specifications and Conditions laid down in the Tender Documents as under:

a) **M/s T.M Anjarwal & Sons Karachi**

M/s T.M Anjarwala & Sons Karachi has submitted complete bid along with all necessary documents and quoted all items of the tender. As per price comparison (CST) M/s T.M Anjarwal & Sons Karachi has submitted the lowest bid.

b) **M/s H.Abdul Ali & Sons Karachi**

M/s H.Abdul Ali & Sons Karachi has submitted all necessary documents, however quoted the rates of all the items. As per comparison (CST) the prices of quoted above to the estimated cost higher than the lowest bidder. Hence the bid is 2nd lowest.

c) **M/s Al- Faisal Karachi.**

M/s Al- Faisal Karachi has submitted incomplete bid, however quoted the rates of all the items. As per comparison (CST) the prices of quoted above to the estimated cost higher than the lowest bidder. Hence the bid is 3rd lowest.

d) M/s Jagani & Brothers Mithi

M/s Jagani & Brothers Mithi has submitted all necessary documents, however quoted the rates of all the items. As per comparison (CST) the prices of quoted above to the estimated cost higher than the lowest bidder. Hence the bid is 4th lowest.

5. In view of the evaluation M/s T.M Anjarwala & Sons Karachi, being the lowest bidder, may be awarded the tender, after seven days of hoisting BER at SPPRA website.
