



3. AND WHEREAS, the Assistant Inspector General of Police, Sindh, in accordance with The Public Procurement Rules, 2010 as adopted by Government of Sindh vide notification No. SORI (SGA&CD) 2-30/2010 dated: 08 March 2010 on the basis Tender Notice published in the newspapers.
4. That M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, provided quotation on the basis of Tender Notice published in the newspapers as per Sindh Public Procurement Rules-2010.
5. That the rates offered by M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, for the Upgradation of vehicle mounted jammer of SSU where approved on the basis of Sindh Public Procurement Rules 2010. Therefore, on the recommendation of Committees, to place work order with M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, on terms and conditions specified below:-.

**NOW THEREFORE PARTIES HEREBY AGREED AS FOLLOWS**


- i) M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, shall Upgradation items, articles described and specified along with quantity the above within 90 days from the date of signing of this agreement.
- ii) That in case of Upgradation work shall be made at AIGP/Security (SSU) Sindh Karachi office, between 0900 hours to 1600 hours on working days only.
- iii) That every items/article shall be made and finished in all respects to entire satisfaction of Departmental Upgradation/Work Committee which shall be at liberty to reject any item/article or part thereof if it is not in accordance with approved specification mentioned in the tender documents submitted by supplier at the time of bidding, and evaluated and approved for this purchase order and such rejection shall be final. The no appeal or review will be permissible against the decision of inspection committee.
- iv) That M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, shall provide proper comprehensive warranty of supplied items on certificate and also certified to provide facility i.e proper maintenance/inspection of items within warranty period of Upgraded ITEMS as and when required by procuring agency.
- v) That M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, shall provide proper comprehensive facility i.e proper training, and operators by foreign experts of the company at Karachi as and when required by procuring agency.


- vi) M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, shall provide 10% Bank Guarantee against total cost of contract and same Bank Guarantee valid at least 90 days beyond the date of completion of contract to cover defects liability period or maintenance period subject to final acceptance by the procuring agency as per SPPRA-2010 Clause-39 (1&3).
- vii) That the AIGP/ Security, Sindh, shall give written receipt signed by him giving out complete details, exhibiting the number of item/articles delivered and the number item/article accepted and rejected, and such receipts shall be conclusive evidence of the acceptance and rejection of the number of item/article specified as accepted and rejected.
- viii) That all article rejected shall be taken back and removed by the M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, and nothing shall become due or recoverable by the M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, in respect on account of item/article so rejected.


- ix) That all above articles and quantities shall be Upgradation by the bidder /firm, subject to condition that requisite document /NOC /permission shall be provided by the buyer, and also payment thereof shall be made on pre-receipted bills in advance against security deposit /bank guarantee of equal /value.
- x) In case M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, make default, in the due performance of this agreement/contract in part or full, AIGP/Security, Sindh shall be at liberty to impose and recover L.D. Charges not exceeding 0.025% per month thereof. The penalty shall be applicable only to the extent of item/article supplied late.
- xi) The AIGP/Security, Sindh shall have right to assess, demand and recover any damages suffered by Police Department due to late supply of the item/article from the supplier.
- xii) The AIGP/Security, Sindh shall be at liberty to deduct and retain the amount so assessed from the bill that may be or may become due and payable at or after the time of such failure to the M/s Aeristech, GF1 Block 12B Sea View Township DHA Phase V ext Karachi, by the said AIGP/Security, Sindh, whether by virtue of agreement or otherwise.

- xiii) The AIGP Security Sindh shall not be responsible for non-performance of this agreement due to change in law, rules and policy of the government as notified in official gazette from time to time.
- xiv) That all conditions laid down in the rules framed for procurement by the Government shall apply to transactions made under this contract agreement and both parties shall be bound by it.
6. This contract agreement shall be construed, and the legal relations created herein will be determined in accordance with the laws of Islamic Republic of Pakistan.
7. Any notice required under this contract agreement shall be in writing and shall be effective when received by the addressee at its given address.
8. If any term, conditions, or provision in this Agreement is found to be invalid, unlawful or unenforceable to any extent, the parties shall endeavour in good faith to agree to such amendments that will preserve, as far as possible, the intentions expressed in the Agreement. If the parties fail to agree on such amendments, such invalid terms, condition or provision will be served from remaining terms, conditions and provisions, which will continue to be valid and enforceable to the fullest extent permitted by law.
9. This agreement may be amended only in writing signed by both the parties.
