2 Opening the discussions, the Chairman welcomed the participants and apprised them that the Department, will procure 1.300 Million Tons wheat out of current crop-2012 against the target fixed by Government. The Department is also holding carry over wheat stocks of more than 150000 tons as such increasing total availability to 1.450 Million tons valuing to **Rs 40.000 billion** approximately. Currently due to bumper wheat crop in the country


and overall carry over wheat stocks coupled with the low open market rates. As such until the market forces allow release of wheat, it is expedient to take all the precautionary measures for the safety & security of the Government wheat stocks till their clearance from the godowns. The committee was apprised that the department does not have expertise for fumigating the wheat stocks to get fumigating work through technical personal for giving guarantee for security of inside & outside of stocks.


