

A meeting of Procurement Committee (PC) for above works was held to discuss Evaluation Report of bids, submitted by the Consultant M/s NESPAK on March 14, 2017.


The Project Manager of Consultant M/s NESPAK briefed all the members of PC regarding the evaluation of bids carried out by them. The Consultant has concluded that all the bidders have not complied and responded to the bid submission requirements. Thus, they recommended that work may not be awarded to any bidder as no bidder qualifies the criteria set out in Bidding Documents.

The PC reviewed Evaluation Report of bidders and discussed it in detail. The PC observed that the Evaluation has been carried out on the basis of criteria set out in the NIT and bidding documents. Keeping in view of above, the PC after detailed discussion unanimously recommends that all bids may be rejected, the bidding process may be cancelled under Rule 25(1) of Sindh Public Procurement Rules 2010 (Amended 2013) and the bids may be invited afresh.

The PC then discussed the revised NIT and bidding documents prepared by the Consultant. The Principle Engineer, NESPAK briefed the members. The PC then finalized NIT & bidding documents and recommended to advertise it as soon as possible.

**1.0 BACKGROUND**

Karachi Fisheries Harbour Authority hereinafter called as KFHA intends to undertake a scheme "Rehabilitation & Renovation of Karachi Fish Harbour - External Services (Part-I)".

**2.0 INVITATION OF BIDS**

For this purpose Bids were invited from interested national contractors/ firms on "Single Stage One Envelope" procedure under SPPRA Rules 2010 (Amended 2013) through newspaper advertisement published on January 16 & 17, 2017 (copy attached as **Annexure-A**).

### 3.0 PRE BID MEETING

Pre bid meeting for the works was held on February 13, 2017 in the office of KFHA.

### 4.0 CORRIGENDUM ISSUED BY KFHA

One Corrigendum for the opening of the Bid was issued by KFHA through newspaper advertisement published on January 27, 2017 (copy attached as **Annexure-A**).

### 5.0 RECEIPT OF BIDS

Eight (08) bidders purchased the Bidding Documents, out of them only four (4) bidders submitted their bids in the office of KFHA.

The submitted bids were opened in the presence of KFHA's, NESPAK's and bidders' representatives on 22<sup>nd</sup> February, 2017 at 1500 hrs.

The prices announced/ quoted by the bidders at the time of bid opening are given as under:

The Bidding Documents of above mentioned bidders were forwarded by KFHA through their letter No. KFHA/DE/2395/2017 dated February 23, 2017 to NESPAK for vetting/ scrutiny and preparation of bid evaluation report. Bid opening statement, summary of cost and KFHA forwarding letter are attached as **Annexure-B**.

## 6.0 EVALUATION OF BIDS

Examination of the received bids was made to establish the compliance of each bidder with regard to submission requirements. A check list in this regard has been prepared and attached as **Annexure-C** to this report.

### 6.1 BID SECURITY

Pursuant to Clause **IB.15.1 & 15.2**, bidders were required to submit bid security for an amount equal to **Pak Rs. 15,000,000/=** (Pak Rupees Fifteen Million) in the form of a bank guarantee issued by a Schedule Bank in Pakistan in favour of KFHA. Copies of Bid Securities are attached as **Annexure-D**.

Pursuant to Clause **IB.15.2**,

*"the Bid Security shall remain valid for a period of 28 days beyond the Bid Validity Date"*

As per above Clause, Bid Security validity was required 118 days. However, M/s. Haji Syed Ameer & Brothers submitted Bank Guarantee which has Bid Security validity 88 days. Other bidders have complied the requirements given in Bidding Document.

### 6.2 CLARIFICATION SOUGHT BY BIDDERS & RESPONSE

No clarifications were sought by the bidders.

### 6.3 CONDITIONS IMPOSED

None of the bidders have imposed any conditions with their bid.

#### 6.4 BID SUBMISSION REQUIREMENTS

Pursuant to Clause **IB.18** of Instructions to Bidders, the bidders were required to submit complete set of Bidding Documents including all appendices duly signed and stamped on each and every page. A check list is prepared as per Clause 7.9(ii) of SPPRA Guidelines and Clause **IB.18** of Instructions to Bidders and is attached as **Annexure-C**. Generally the bidders comply these requirements except as noted in the check list.

#### 6.5 SCRUTINY OF BILL OF QUANTITIES

The multiplication of unit rates with quantities and the total amount quoted in the Bill of Quantities were checked and errors were found in three bidders i.e. M/s. Gul Construction Co., Joint Venture of M/s. Nazir Construction Company & A.A. Memon and M/s. AA Quality Builders (Pvt.) Ltd. These errors have been corrected. A summary of corrected bid price is prepared and attached as **Annexure-E**.

## 6.6 Eligible Bidders

All the bids evaluated using the following criteria:

- i) The bidder should provide company profile.
- ii) Valid Registration with Pakistan Engineering Council in Constructor's Category C-2 or above with specialization codes CE01, CE09 & CE10. The bidder to engage specialized firm(s) (with specialized codes as specified) as Joint Venture (JV) for Security & Surveillance System (EE02), High Voltage Installation (EE05) and Specialized Lighting System (EE06).
- iii) No Joint Venture allowed for civil & plumbing works.
- iv) The bidder should have relevant experience of at least two (02) Projects (a project comprises building works, water supply/ fire fighting system, sewage system, external electrical works and road works) having cost Rs. 450 million or above for each project completed during last ten (10) years (Letter of Award, completion certificates any other relevant documents to be attached).
- v) The bidders should have an average annual turnover during last three years Rs. 800 million or above per year as per audited balance sheets from Chartered Accountant firms.
- vi) Bank balance / available bank credit limit (latest) should be at least of Rs. 200 million.
- vii) Income tax returns for the last three years.
- viii) Valid Registration with Income Tax Department, Sindh Revenue Board, Sales Tax Department.
- ix) Affidavit to the effect that the firm has never been blacklisted.
- x) The bidders should submit details of litigation history and arbitration with government agencies and their outcome.
- xi) Affidavit to the effect that all documents/ particulars/ information furnished are true and correct, if any information found incorrect/ misleading, the Procuring Agency reserves the right to reject the bid.

After review of the applications, it was noted that all the applicants had provided incomplete/ unclear information(s), attached as **Annexure-F**. The following was noted:

**6.6.1 M/s. Gul Construction Co.**

- The firm did not submit a valid Pakistan Engineering Council (PEC) Certificate.
- The firm provided only one project for Building Works, however two projects were required.
- The firm did not submit the projects in External Electrical Works.

**6.6.2 Joint Venture of M/s. Nazir Construction Company & A.A. Memon.**

- The firm did not submit a valid Pakistan Engineering Council (PEC) Certificate.
- The firm did not provide any project for Building Works.
- The firm provided only one project for Water Supply/ Firefighting and Sewage Works, however two projects were required. Taking over Certificates/ Completion Certificates were also not provided.
- The firm did not submit the projects in External Electrical Works.
- Taking over Certificate/ Completion Certificate not provided for one project of Road Works.
- Audited Balance Sheets for 2014 & 2015 not provided.

Based on the above conclusion, it is therefore recommended that work may not be awarded to any bidder as no bidder qualifies against the criteria set out in Bidding Documents.



Following points were discussed in the meeting:

1. *Contractor requested for mobilization advance and performance security on insurance guarantee.*

Director Engineering KFHA informed that for mobilization advance and performance security the SPPRA Rules only allows bank guarantee from the scheduled bank in Pakistan as referred in the Bidding data of Bidding Documents (Vol:1).

2. *Contractors requested for extension of time in submission of bids.*

Director Engineering replied that already 5 weeks have been provided for submission of bid hence extension of time in its submission is not justified, therefore, submission date cannot be extended.

3. *Contractor requested for physical site visit.*


