



- As per NIT in order to evaluate the proposals, the required documents were checked and found that the Five parties/firms/suppliers as at sr.1 to 5 above have qualified hence in order to provide opportunity of competitive atmosphere they have allowed to participate for opening of "Financial Proposals" for which all the parties/firms/suppliers were agreed to.

Furniture & Fixture

- Five parties/firms/suppliers viz(1) M/s. S.H Sons (2) M/s. Hassain Furniture (3) A.N.I Trading Company (4) M/s. Mosin Enterprises and (5) M/s. W.S Enterprises applied for and submitted technical proposals.

Machinery Equipment

Sewing Machine

> The Financial Proposal of following bidders i.e. (1) M/s. Faiz Scientific Company, (2) M/s. W.S Enterprises (3) M/s. ANI Traders, (4) M/s. Hammad Enterprises, and (5) M/s. Bismillah Enterprises. Were opened on dated 19-02-2015 the representative of bidders were present and signed the attendance sheet. The first lowest M/s. Faiz Scientific Company offered "Vilke" Sewing Machine @ 5710 which was found not according to tender specification & sub standard machine so committee rejected the proposal of the bidder. The second lowest M/s. W.S Enterprises offered the Signer H-150 Sewing Machine along with motor & cover @ 6200 later on the bidder informed to the procurement agency that, he will not provide Sewing Machine with required all accessories like Electric Motor & Cover in quoted rate, the copy of bidder intimation is enclosed. The 3rd lowest M/s. ANI Traders, Salika Sewing Machine with all accessories Electric Motor & Cover @ 6996 per Sewing Machine & total bid cost of Rs.8395200/= Salika Sewing Machine being a popular famous & good material / condition according to the specification considered according to the required tender specification so committee approved the offer of the same.

Tri Cycle

> The "Financial Proposal" of following bidders i.e. M/s. ANI Traders , & (2) M/s. W.S Enterprises hence the rate quoted by M/s. ANI Traders considered the 1st lowest bid/rate i.e. Rs.6,900/= per Try Cycle and total bid cost is Rs. 69,000/= therefore, the Committee recommended to award the work to M/s. ANI Traders after necessary approval of competent authority.

Salika Zig Machine

> The "Financial Proposal" of following bidder M/s. ANI Traders , & (2) M/s. W.S Enterprises hence the rate quoted by M/s. ANI Traders considered the 1st lowest bid/rate i.e. Rs.14,800/= per ABC Zig Machine and total bid cost is Rs. 44,400/= therefore, the Committee recommended to award the work to M/s.
