In the above case, Three (03) Firms namely M/s. Quick Marketing Service, M/s. Ideal Distribution Lines & M/s. Pros-link have been participated whereas the Firm namely M/s. Pros-Link bid has been rejected as a nonresponsive bid while M/s. Ideal Distribution Lines have been dis-qualified in Technical Proposal who attained 44% Marks out of 100% Marks, since the minimum score required in Technical Assessment was 70% Marks out 100% Marks, Hence only single Bidder had qualified in the Financial Proposal who has fulfilled all the required criteria as mentioned in the Standard Bidding Documents, Hence Departmental Purchase committee unanimously determined to get the market price for the said stores through calling quotations from HP-Authorized Distributers prior to the award of contract to M/s. Quick Marketing Service in terms of Rule-48 of SPPRA-2010 (Amended-2013) which stated that; "Even only one Bid is submitted, the bidding process may be considered valid, if the bid was advertised in accordance with rules, and prices are comparable to the prices or rates of the last awarded contract or the Market Prices".

Accordingly, prices obtained from Three (03) Hp-Authorized Distributors reflected that the cost offered by M/s. Quick Marketing Service has lowest in price; hence Procurement Committee proposed that supply of Cartridges/Toners for Printers should be placed with M/s. Quick Marketing Service.

Meeting of the Departmental Procurement Committee constituted vide Finance Department's Notification No. FD (CTC-I) 04(04)/ 2015-2016 dated 16<sup>th</sup> March, 2016 & 31-03-2016 was held on 05th April, 2016 at 1:00 P.m in the office of Additional Finance Secretary (B&E)/Chairman of the Committee, in order to undertake the Technical Appraisal of the Bids submitted against the Finance Department's Tender Notice vide Advertisement No. INF-KRY 945/16 in Three Leading Newspapers namely "The English Daily Dawn, Urdu Daily Express & Sindhi Daily Kawish" as well as hoisted on Finance Department & SPPRA official websites with the SPPRA Sr No. 26990 uploaded on 16-03-2016 whereas the SPPRA I.D will be released after furnishing of Original Bid Evaluation Report, Technical Evaluation Report, Financial Evaluation Report & Award of Contract to the SPRR Authority.

The Committee members were informed that, in response to the Tender advertisement, following Three (03) Firms had gotten the bidding documents issued against a cash of Rs. 2,000/- only (non-refundable Tender Fee), that are;

- However, Out of above Four Firms, only Three (03) Firms at Serial Nos. 1, 2 & 3 have submitted their Bids by the deadline of 12:00 Noon on 05th April, 2016.
- Accordingly, the bids were opened on 05th April, 2016 at 01:00 P.m in presence of the above mentioned Bidder's Authorized Representatives who also signed the Attendance Sheet. All the members of the procurement committee signed the Sealed Envelopes of the Technical Bids and also Technical Documents.
- Finance Department had adopted Single Stage-Two Envelopes Procedure as prescribed in SPPRA Rules "Procedure of open Competitive Bidding" for selection of Firms.
- The Committee proceeded as per prescribed procedure of Rule-46 sub Rule-2 of SPPRA-2010 (Amended-2013), initially, only the Envelopes marked as "Technical Proposals" were opened in presence of the Bidders and the Envelope marked as "Financial Proposal" retained in the custody of Departmental Procurement Committee without being opened.
- The Procurement Committee than examined the Technical Bids without reference to the Price as per the Preliminary Elimination Criteria & Eligibility Criteria provided in the Bidding Documents, Arithmetical checks and verify the Documents submitted by the Bidders on the basis of parameters specified in Tender Bidding Documents.
- 8. Accordingly, Prior to the Technical Bids Evaluation, Procurement Committee has examined these three Bids, either bids are responsive or non-responsive on the basis of Preliminary Screening Criteria as mentioned in the Standard Bidding Documents and found that the M/s. Pros Link has not submitted its Technical Bid as per the required criteria whereas M/s. Quick Marketing Service & M/s. Ideal Distribution Line have grasped out with minor nonconformity which were waived off by the Procurement Committee, hence Departmental Procurement Committee has rejected the proposal of M/s. Pros-Link and disqualified the said firm from Tender Process. (Preliminary Screening Criteria of the Three Bids is attached with Minutes at Annexure-I), while the Two (02) Firms namely M/s. Ideal Distribution Line & M/s. Quick Marketing Service have qualified for further Technical assessment as per the Evaluation Criteria as specified in Standard Bidding Documents.
- 9. Consequently, M/s. Quick Marketing Service & M/s. Ideal Distribution Lines have obtained 85% Marks & 44% Marks respectively whereas M/s. Ideal Distribution Line has not succeed Technically due to scored less than 70% Marks since the minimum marks required as specified in Tender Bidding Documents to pass for Technical Proposal was 70% Marks out of 100% Marks. (Evaluation Criteria of the Bids attached with minutes at Annexure-II).

Q.M.S through invited quotations from local market prior to the award of contract as follow-up the Rule-48 of SPPRA-2010 (Amended-2013) which stated that: "Even when only one bid is submitted, the bidding process may be considered valid, if the bid was advertised in accordance with rules, and prices are comparable to the prices or rates of the last awarded contract or the market price".
- Accordingly, prices obtained from Three (03) firms reflected that the cost offered by M/s. Quick Marketing Service has lowest in price. (Price Comparison along with Three (03) quotations are attached with minutes at Annexure-A).
- 5. Accordingly, the Procurement Committee proposed that the contract for supply of Cartridges for printers should be placed with M/s. Quick Marketing Service with the total bid amount of PKR. 4,734,135/- (Rupees: Four Million Seven Hundred Thirty Four Thousand One Hundred & Thirty Five) only inclusive of all taxes. halad lam


