COMMENTS ON TECHNICAL PROPOSALS:- MINUTES OF MEETING OF RE-TENDER ENQUIRY NO. 01 (a) OF 2013 (2013-2014) OF SERVICES HOSPITAL HYDERABAD AND THREE DISPENSARIES LOCAL PURCHASE OF MEDICINES/DRUGS, WITHIN ALLOCATED BUDGET i.e. 15% OUT OF BUDGET FOR THE YEAR 2013-2014 HELD ON 25-10-2013 AT 12.00 NOON.

As per Government Notification No. S.O. (PM&I) 2-1/2013 (CS/HYD) Karachi dated 13-8-2013, Meeting of Members of the Procurement Committee and other participants under the Chairmanship of Dr. Zulfiqar Ali Khawaja Chief Resident Medical Officer Services Hospital Hyderabad was held on 25-10-2013 at about 12.00 noon.

The meeting commenced with the Recitation of Holy Quran verses. Following bids were received from (1) M/S I.B. Pharma Hyderabad (2) M/S Channal-4 Hyderabad & (3) M/S Ruby Medicoes Hirabad Hyderabad. The attending participants introduced themselves with all members of Procurement Committee, meanwhile separate attendance sheet was also signed by the participants. After that Envelopes of the Technical Proposals and Envelopes of Financial Proposal were numbered and separated. Financial Proposal were retained separately in the custody of procuring agency without being opened.

Then after the Technical Proposals were opened in front of all participants publically and the pages of the Technical Proposals were signed by each member of Procurement committee.

After completing the process, committee unanimously declared the evaluation report of Technical Proposals after due scrutiny publically in the presence of participants, attending the meeting which is as under.

Following three in number bidders participated (1) M/S I.B. Pharma Hyderabad (2) M/S Channal-4 Hyderabad & (3) M/S Ruby Medicoes Hirabad Hyderabad.

After due scrutiny by the members of the Procurement committee are of the unanimous opinion that the following documents were not submitted by the bidder in the Technical Proposal of M/S. I.B. Pharma Hyderabad, NTN, & I.T. Return, Bank Transaction Statement, and incompletely filled-in Affidavit.

It was also observed that M/S. Channal-4 Hyderabad did not submitted NTN & I.T. Return, Bank Transaction Statement. There is no valid drug selling license, and incomplete Affidavit is submitted.

Hence the Procurement Committee unanimously do not accept / qualify the bids of M/S. I.B. Pharma Hyderabad & M/S. Channal-4 Hyderabad, the Financial Proposal is hereby returned back un-opened publically on 25-10-2013.


The Technical Proposal of M/S. Ruby Medicoes Hirabad Hyderabad was scrutinized by the members of Procurement Committee which was meeting the Eligibility Criteria i.e CNIC, NTN, I.T. Return, Drug Selling License, Bank Transaction Statement, Affidavit, Undertaking and hence was accepted.

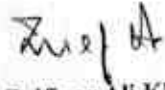

The maximum discount offered in the comparative statement was found to be of M/S. Ruby Medicoes Hirabad Hyderabad.

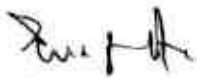
