In pursuance to your legal notice dated 28-05-2014, served upon (1) The Director School Education, Larkana Region, Larkana, (2) The Director School Sukkur Region, Sukkur, (3) Sindh Public Procurement Regulatory Authority (SPPRA) Barack-8, Sindh Secretariat 4A, Court Road, Karachi, (4) The Secretary Education & Literacy Department, Government of Sindh, Sindh Secretariat, Karachi and copy endorsed to my client M/Science & Computer Link, having their registered office at Karachi, I under the specific instructions and on behalf of my client, replied you as under:

1. That my client is a sole proprietorship concern established by Mst. Khair-un-Nisa Bibi W/O. Syed Maqbool Hussain Rizvi and duly registered with all relevant Government Departments. That our client running the business since several years and achieved several tasks and completed all the tenders/contract assigned to them in time. That our client has an Organizational structure with departments, their teams with heads. The business of our client and its branches are spread all over Pakistan. That during her life time, due to her serious illness, she has nominated her Son Syed Tahir Inam Rizvi as the

That your clients are well aware that, my client is the only company appearing in the instant tender, who have all the capabilities to meet standards of Government Departments and their bid for technical purpose will be accepted and they have the capability for provide the material according to the specifications and requirement of the department, whereas your clients have no work profile and experience to meet the bare standards of the requirement of Government Departments, hence they keen to eliminate my client's company by misrepresentation of facts.
3. That the allegation raised by your clients in the notice dated 28-05-2014 based on malafide intent and clear misrepresentation of facts. Your allegation that the bid documents were signed by the late Khair-un-Nisa is false and frivolous in order to achieve your client's nefarious design. It is pertinent to mention here that the bid documents are signed by the concerned Manager, who is duly authorized to do so by the incumbent Proprietor.
4. That you have admitted in your above referred notice, that your clients made illegal and unauthorized attempt to illuminate my client from participating in tender bidding and also compelled and pressurized the relevant departments to reject and or not accept the bid of my client, which is prim-facie and clear violation of Constitution of Pakistan, which ensured the liberty of business to each and every citizen of Pakistan.
5. That the allegation raised in your Notice dated 28-05-2014 is based on ignorance of law and with malafide intent. That you are deliberately and intentionally attempting to misguide the concerned departments in order to achieve your nefarious design to usurp the Government funds in collusion with the so called dummy organizations. It is reiterate that your allegation that the bid document filed by the late Mst. Khair-un-Nisa is false and frivolous. That your allegations are shown your ignorance of law. The bid documents were signed and filed by the authorized and competent person, duly authorized by the

- 3) **Registrations/ certifications/ memberships:** This firm provided NTN certificate # 1517571-5 , CST Certificate # 1700999966064, Professional Tax Certificate, The Certificate of firm's membership No. 80536 vide serial No. B 25969 Book No. B 02597 issued from Karachi Chamber of Commerce is expired in March 2014, but the firm has provided Membership Renewal Receipt v.de No. 14032014000097 Bill No. 14964, however the membership with KCCI is considered as valid and acceptable, The Bidder has not produced SRB Certificate, but it has provided a printout taken from SRB website showing its status as registered in SRB, which is verified from the website of Sindh Revenue Board "<https://e.srb.gos.pk/Registration/onlineSearchTaxpayer.aspx>" and confirmed that the bidder is registered in SRB. Acquires **50 marks.**

- b) The firm has paid Income Tax more than 2M annually which matches with the Turnover requirement.
- c) Monthly GST Returns of Last 15 months were required, Bidders were supposed to submit GST returns from Jan 2013 to March 2014, but this firm has submitted old Returns from July 2011 to Dec-2012, these are not required in the tender document, hence cannot be considered. SRB Certificate is not produced. **Acquires 30 marks for three Certificate.**

Observations:

- a) The Balance Sheet of this firm shows very heavy turnover of more than 152Million annually on average basis, but the Annual Income Tax Return and Monthly GST documents tell different story, for details see paragraph "b & c" bellow.
- b) The firm has paid Income Tax less than 03 Lac in 3 years, and declared turnover under 9.3M in three years which is nothing against the Turnover as shown in its Balance Sheet.

- c) GST documents of 15 months show that this firm has made sales of only 3 Lac and 9 thousands, which also doesn't match with turnover as shown in its Balance Sheet.
- d) Bank Certificates provided by the bidder from UBL saying that this firm can handle projects up to 100M with their own resources but, its bank statement of NBP AC No. 005676-5 from 01-07-2012 to 27-12-2013 (18 months) shows the turnover is just Rs:371,349.00. Therefore the certificate seems to be without basis and without any justification and has no cause of authenticity.

It is further noted that this firm has produced a LETTER of FBR vide letter No. DCIR/AUDIT-I/SUK/2013-14/3071 dated 14-04-2014 which was written by the Tax officer to the bidder, but the bidding firm has submitted such letter as "AUDIT CERTIFICATE". Which cannot be accepted.











In the light of SPPRA Rule 30/1, such tactical presentation of documents is under question mark, and liable to disqualify the firm.

Remarks:

The observatory paras as stated above in (a to d) raise many questions on firm's FINANCIAL STATUS as required in SPPRA guidelines. **Therefore for Financial Status this firm is disbelieved thus cannot acquires marks for this section.**
