During item-wise scrutiny, checking of rates and total of each bidder, some minor mathematical errors were found in calculation. The corrected amounts are tabulated in comparative sheet which are as:

Further, while comparing the bids with the estimated cost, it is observed that the first lowest bidder namely M/s Malik Iqbal & Co. has quoted his bid lower than the estimated cost (without escalation amount of Cement, Bricks & Steel Rs.9,725,105) by 0.07% whereas, remaining three bidders namely M/s Pakistan Electric Works, M/s Mian Abdul Jabbar & Co and M/s AIKES Pvt Ltd, have quoted their bids higher than the estimated cost by 5.44%, 5.50% and 32.45% respectively.

Conclusion / Recommendations:

- We are of the opinion that since tendered cost of M/s Malik Iqbal & Co. who are the 1st lowest is workable and within the estimated cost, therefore, it is recommended that the work of construction of Electrical Engineering Department at MUCET Khairpur be awarded to him.
- 2. The work order to be issued to contractor M/s Malik Iqbal & Co. as per following details:
 - The contractor shall be paid 52% above premium only on Civil works schedule items, 50% above on Plumbing work schedule items, 55% above on External Civil works schedule items & 45% above on External works drainage system schedule items.
 - The escalation on Steel at rate Rs. 1600/- per Cwt, Cement at rate Rs. 205/- per Bag and Bricks at rate Rs. 3800/- per 1000 Nos shall be paid separately as per actual consumption of these items at site. This mode of payment of escalation is proposed to comply with provision of Clause 52 of Tender Documents (at page no 41.)
 - The contractor shall not be paid any escalation or difference of material on any nonschedule item.
 - The contractor shall not be paid any cartage separately.
 - The contractor to submit Construction Schedule before issuance of work order

This is for your record and further necessary action. We are returning you all the four (04) original tender documents along with Bid Evaluation Report.
