3. M/s Malik Iqbal & Co.

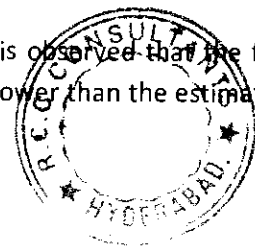
Following were the Contractors' quoted original Bid Amounts

During item-wise scrutiny, checking of rates and total of each bidder, some minor mathematical errors were found in calculation. The corrected amounts are tabulated in comparative sheet which are as:

Further, while comparing the bids with the estimated cost, it is observed that the first lowest bidder namely M/s Pakistan Electric Works has quoted his bid lower than the estimated cost by



0.28% whereas, remaining two bidders namely M/s Mian Abdul Jabbar & Co and M/s Malik Iqbal & Co, have quoted their bids higher than the estimated cost by 8.43% and 12.86% respectively.

Conclusion / Recommendations:

1. We are of the opinion that since tendered cost of M/s Pakistan Electric Works who are the 1st lowest is workable and within the estimated cost, therefore, it is recommended that the work of construction of Internal/External Electrification, Computer Networking & Air Conditioning Works For Petroleum & Gas Engineering Department And Basic Science & Related Studies Department at MUCET Khairpur be awarded to him.
2. The work order to be issued to contractor M/s Pakistan Electric Works as per following details:
 - The contractor shall be paid 25% above premium only on Section 'A' Internal Electrification Schedule Items from serial no 01 to 10 only.
 - The contractor to submit Construction Schedule before issuance of work order
