#### MINUTES OF VISIT TO TENDERED VENUE AT HYDERABAD.

The procurement committee paid visit to the tendered venue on 12-02-2018 at 14:00 as to ascertain and verify the physical condition of premises and other available facilities as per tendered requirement prior to finalize the bidding process for Regional Office of Inspectorate of Coal Mines at Hyderabad. The said visit was paid by the following officers of procurement committee along with the concerned Land load:

- 1. Mr. Irshad Ali Shaikh, Chief Inspector of Coal Mines Sindh, Karachi Chairman Procurement Committee.
- 2. Mr. Syed Muhammad Waseem, Inspector of Mines Karachi, Member, (A Representative from Inspectorate of Mines, Mines & Mineral Development Department)
- 3. Mr. Qamaruddin Soomro, Inspector of Coal Mines Hyderabad, Member.

During the visit, the Landlord briefed the committee that the covered space of the first floor of building is 600 sq. yards located at Latifabad unit No. 03, near Auto Bhan Road, Hyderabad and informed about the available facilities in the first floor of building, which were considered satisfactory as per tendered requirement. The renovation work was in progress at the time of visit.

The building have four (04) rooms at the first floor and one (01) room on the top floor plus three (03) attached bathrooms, one (01) kitchen, one (01) servant guarter, a hall & store room and two (02) dedicated vehicle parking.

Finally, the Procurement Committee has unanimously satisfied after visiting the premises and found fit for acquiring the said premises on monthly rental basis for the Office of the Inspector of Coal Mines Hyderabad.
