SUBJECT: - PROCUREMENT COMMITTEE MEETING HELD ON 16-05-2016.

2. The below mentioned members of committee attended the meeting to discuss the bids invited for the procurement of works vide Executive Engineer, Provincial Buildings Division No.III, Karachi letter **No.TC/G-55/PBD-III/2015-16/625 dated: 29-04-2016** and subsequently hoisted on the website of Sindh Public Procurement Regularity Authority and Information Technology Department Government of Sindh.

3. During the course of meeting following discussion/decisions were made by the committee:-

- i. The tenders purchased by the bidders up to date: 16-05-2016 at 12:00 PM were opened before the procurement committee in presence of representatives of participants.
- ii. The method for bidding was single stage - one envelop.
- iii. The bids were opened on 16-05-2016 (at 3.00 PM) before the Procurement Committee.

The committee was informed that 27-Nos bidders have purchased the bidding documents for all the 09 works out of 10 works up to date: 16-05-2016 (12.00 P.M) and 24-Nos have submitted the bids on 16-05-2016 up to 2:00 PM in the office of the Executive Engineer, Provincial Buildings Division No.III, Karachi.
