

- Sealed tender may be submitted in the name of Principal KMDC, and the category should be marked at the top of corner on either corner (RT or LT) of the envelop.
- Tenders should be legibly filled in link total should be correctly made.
- Convincing by Tenderers/ or his agent shall made the tender liable to cancellation.
- No alteration will be allowed to make in the tender condition is this contract.




