**TERMS & CONDITIONS.**

1. In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 04.10.2016 and the tender documents will also be available up to 03.10.2016.
2. The tender documents will be issued to the firms on submission of application in their original letter head along with pay order of Tender Cost in favor of Executive Engineer, Building Division No.III, Works & Services Department Karachi as mentioned above.
3. **2% of Bid** quoted amount in shape of Pay order/Bank Draft, in favor of Executive Engineer, Building Division No.III, Works & Services Department Karachi Shall must be attached with the tender documents with out which the tender will be treated as cancelled.
4. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures, incomplete/ conditional tenders will not be accepted. In addition the bidders must be furnished documentary evidence against each eligibility criteria as mentioned above, other wise their tender will be summarily rejected without consideration.
5. The tender can be downloading from SPPRA's website.
6. In case the date of opening declared as a Public holiday by the Government or non working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.

7. The procuring agency may reject all or any bids or proposals at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA rules.
8. In case of firm being partners/ partnership deed, given full particulars of Director/ Proprietors or other connected along with power of attorney. In case of being whole proprietor such under taking on affidavit is furnished.
9. Affidavit to the effect that the firm is not involved in any court case and that no work has been left by the firm incomplete.
10. Documentary evidence regarding under completion/ completed works along with satisfactory completion certificate from the concerned department.
11. An affidavit to the effect that the firm/ contractor are not blacklisted by any executing agency should be enclosed with the bid.
12. Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who report canvassing will liable for rejection..
13. Tenders will not be received after the schedule time.


The successful contractors, whose tenders are accepted, will have to obtain adhesive stamps from Assistant Superintendent Stamps, Govt. of Sindh; Karachi on payment of Stamps according to Schedule prescribed in the clause (a) article 15 of the stamp act 1899 amended rule 2009 and signs the agreement.
