**The Appellant's Version:-**


The appellant submitted that he had visited the office of the procuring agency on the day of the opening of bids but the procurement committee was not present and he was informed by the officials of the procuring agency that the bids shall be cancelled. The appellant submitted that he waited for the cancellation of bids but the procuring agency did not cancel the bids nor opened the bids publicly.

**The Procuring Agency's Version:-**


The procuring agency submitted that the bids were opened on the scheduled time and venue but the appellant did not participate in the bidding process. It was also informed that the evaluation of bids was not carried out as the matter was pending before the Review Committee. The procuring agency submitted that they were ready to cancel the bids as the matter had been made controversial by the appellant by filing complaint before the Review Committee.

**Decision of the Review Committee:-**


The Review Committee observed that the procuring agency is ready to cancel the bids in order to resolve the controversy hence the matter does not require further proceedings. Given the discussion made above, the Review Committee decided to direct the procuring agency to terminate the procurement proceedings of the NIT in terms of Rule-32 (7) (f), as the procurement contract has not been signed.




