In compliance of the orders passed by the Honorable High Court of Sindh, Karachi, during hearing of Constitutional Petition No.D-822 of 2019 on 13.02.2019 to decide the matter lodged by M/s M.B. Royal Enterprises, Hyderabad, (the appellant) against Executive Engineer Buildings-II, Works & Services Department, Karachi (the procuring agency), a meeting of the Review Committee of Sindh Public Procurement Regulatory Authority (SPPRA) was convened under the chairmanship of Managing Director SPPRA in accordance with Rule-32 of SPP Rules, 2010 (Amended Up to date).

2. Accordingly, the Authority vide letter dated 15.02.2019 issued notices to the concerned parties for appearing before the Review Committee on 20.02.2019 at 12.30 p.m. in Committee Room of SPPRA, Barrack No.8, Sindh Secretariat Block-4A, Court Road, Karachi. In compliance, Engineer Wadhmal, Director, office of Director General (Design), Works & Services Department (representative of the procuring agency) appeared before the Committee; whereas, the representative of the appellant did not appear in the meeting.

3. Engineer Wadhmal submitted a copy of letter dated 18.02.2019 – duly issued and signed by the appellant – to the Committee whereby the appellant withdrew its complaint filed against the procuring agency. Subsequently, the Authority verified withdrawal letter from the appellant who confirmed about it.

**Review Committee Decision**

4. Since the appellant withdrawn the case against the procuring agency, therefore, the committee decided to dispose-off the matter with no further action.
