1.13 The quoted rates shall remain valid till the end of the current financial year.

2. Special Conditions:

- 2.1 Store is required within the stipulated delivery period. No extension will be granted / accorded for the supply of initial quantity.
- 2.2 The bidders shall quote their firm and final price both in figures & words on "free delivery basis to consignee end.
- 2.3 Distributor once nominated by the manufacturer will be for the whole contract period and manufacturer can not change its distributor during the year in any case. In exceptional cases the procuring agency may approve changes.
- 2.4 No manufacturer shall authorize their distributor/ agent / any firm or person to quote the same item, which the manufacturer is quoting itself in any tender. Failing those offers of both the manufacturer as well as other bidder shall be ignored.
- 2.5 The supplier shall furnish the certificate from the manufacturer on who's behalf they are participating to the effect that in case of the drug supplied declared sub- standard the participating firm as well as the manufacturer are equally responsible for legal consequences under purchase rules envisaging black listing.
- 2.6 The bidder shall confirm the refund of cost difference if the same medicine / drug is / was supplied at lower rates to any other Govt: / semi Govt: institution or Armed forces in the province or out said for local manufacturers in the same fiscal year, if medicines are mfgd: in Sindh and quoted rate to other province in found lower, then payment will be made on lower quoted rates to any province.
- 2.7 The purchaser reserves the right to enhance / decrease or delete the quantities at the time of award of contract with out any change in unit price or other terms and conditions of the tender at any time during contract period.
- 2.8 The procuring agency may reject all bids or proposals, at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor, who submitted a bid or proposal, the grounds for its rejection of all bids or proposal, but is not required to justify those grounds. The procuring agency may reject all or any bids subject to the relevant SPPRA rules

- 2.9 Subject to the fulfillment of all codal formalities, the purchaser will award the contract to the successful bidders whose bid has been determined to be qualified to perform the contract satisfactory. Both the parties' i.e. the purchasers and the supplier will sign the contract agreement on the stamp paper with stamp duties as per prevailing Govt; rules, the expenditure involved on the said contract agreement will be borne by the supplier.
- 2.10 Manufacturing, expiry dates and batch No. will be written on the each pack. No drugs / Medicines and disposable item will be accepted having shelf life less than 95% to 100%.
- 2.11 The manufacturer and the supplier both shall be responsible for any breach of the contract agreement and the terms & conditions of the tender.
- 2.12 SPPRA rules shall override all the terms and conditions of the tender.
- 2.13 In case of products declared sub- standard by the PDTL / CDTL or rejected by the inspection committee, the supplier shall have to provide additional quantities of the same.

Bid security.

Every bidder will have to submit bid security in a sealed envelope at the time of tender submission at the rate of 2.5% of the total bid amount. Same will be released after successful completion of stores, NOC from consignee and concerned quarters.
