6. The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This guarantee will be released after completion of work.
 7. An amount equal to 5% from each bill will be deducted as Retention Money. which will be released after successful expiry of maintenance period.
 8. The tender documents can be had from the office as mentioned above on any working day during office hours except the date of opening.
 9. All the tender shall be dropped on as per above Schedule up to 02:00 p.m and will be opened by the Tender Opening Committee in the office of S.E (DMC, West Zone, Orangi, Karachi, at 02:30 p.m in presence of the contractor who wish to be present.
