
TERMS & CONDITIONS

1. Tender schedule shall be as follows:

2. In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 16-01-2012 and the tender documents will also be available upto 14-01-2012.
3. The tender documents will be issued to the firms on submission of application in their original letter head alongwith Pay Order of Tender Cost in favour of K.M.C as mentioned above.
4. The Bid Security as mentioned above in shape of pay order / bank guarantee in favour of K.M.C shall must be enclosed with tender documents without which the tender will be treated as cancelled.
5. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will be not accepted. In addition the bidders must furnish the documentary evidence against each eligibility as well as minimum qualification criteria as mentioned above. Otherwise their tender will be summarily rejected without consideration of their bid amount.
6. The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This guarantee will be released after completion of work.

7. An amount equal to 5% of Contractual Value will be deducted as Retention Money, as per condition of contract which will be released after successful expiry of maintenance period.
8. In case of un-workable rate, KMC may ask the bidder to furnish additional performance guarantee of an amount equal to 10% of estimated (Construction) cost as mentioned in the NIT in shape of Pay Order or Bank Guarantee in favour of KMC at the time of agreement, which will be released alongwith the Retention Money. In case of non-furnishing this additional performance guarantee, the bid security will be forfeited and other action including black listing will be taken as per rule.
9. The tender documents can be had from the office as mentioned above on any working day during office hours except the date of opening.
10. All the tender shall be dropped on as per above Schedule up to 02:00 p.m and will be opened by the Tender Opening Committee in the office of Director General (Technical) KMC, 4th Floor Committee Room, Civic Center, Gulshan-e-Iqbal, Karachi at 02:30 p.m in presence of the contractor who wish to be present.
11. In case the date of opening declared as a public holiday by the Government, or non working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
12. The Procuring agency may reject all or any bids or proposals at any time prior to the acceptance of a bid or proposal, *subject to the relevant provision of SPPRA Rule 2010.*
13. No bidder can purchase the tender of more then 04 Works of this NIT.
14. Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who report canvassing will liable for rejection.
15. Tenders will not be received after the schedule time.
