

1. Tenderers are requested to submit sealed tender upto 14-01-2012 at 02 pm in the office of Deputy Director (Estt:/Admin), Zulfikarabad Development Authority, Government of Sind, situated at Ground floor, Bahria Complex-I, M.T Khan Road, Karachi.
2. Tenders will be opened on the same day at 15 hours in presence of the tenderers / bidders or their authorized representatives.
3. Tenderers / bidders are requested to mention make, model, year of manufacturing / country of origin and other specifications of the respective item(s) of store, failing which their offer will not be entertained.
4. Tenderers/bidders are requested to quote their rates in two alternative plans i.e. (a) rates excluding custom duties, sales tax, income tax, withholding tax, excise duty & other levies and (b) rates inclusive of all taxes, duties e.g. 3.5 % income tax and 15% sales tax on the invoice price and charges for packing, handling etc. and also furnish valid Sales Tax Registration Certificate (Photocopy) duly stamped by the concerned authority in favour of respective firm, failing which offer will not be entertained.
5. In case validity offered by the tenderer / bidder is shorter than validity required in the tender, such tender/offer will be ignored / rejected.
6. EARNEST MONEY: All firms whether registered or un-registered shall have to provide order or Bank Draft @ 2.5 % of the total contract price. Cash or Cheque (Bearer/Crossed) will not be entertained.

7. Original purchase receipt of tender documents must be enclosed along with the offer / bid, otherwise offer will not be entertained.
8. The store is required as locally available and therefore required to be quoted in local currency i.e. Pakistan Rupee.
9. The validity of the offered rates should be atleast sixty (60) days from the date of opening of tender.
10. The successful tenderers/bidders will have to enter in a written contract with the Deputy Director Estt: / Admn, Zulfikarabad Development Authority, Government of Sindh, before initiating any supply of store and performing other related assignments. The agreement will be dully stamped at rate of Rs. 0.03 of contract amount.
11. The successful bidder is required to enter in aforesaid contract within a week's time after he/she being asked to supply the stores in the form of supply order/advance acceptance. The contract will be executed subject to furnishing a Security Deposit / earnest money equivalent to 2.5% of the total value of contract, shall be applicable to all registered firm and un-registered firm in the form of call Deposit, Pay Order or Bank Draft. Cash or Cheque (Bearer/Crossed) will not be entertained. In case of failing to enter the contract within stipulated time, the supply order/advance acceptance will be treated as cancelled.
12. All supplies should be made within 30 (thirty) days. This delivery period will not be extended and tenderers/bidders who fails to deliver the store shall face forfeiture of their security deposit.
13. The stores are required to be delivered at the consignee's end i.e. Deputy Director Estt: / Admn, Zulfikarabad Development Authority, Government of Sindh.

**SPECIAL CONDITIONS**

1. Firms registered with the Directorate of Industries (Supply Wing) Government of Sindh Karachi shall furnish photocopy of their valid Registration/Renewal Certificate with the offer/tender.
2. Tender documents submitted by the respective tenderer/bidders should be properly sealed.
3. Tenderers/bidders are required to quote the rates separately against each item both in figures and words on their letterhead duly sealed and signed and not on tender documents.
4. Stores are required to be delivered within 30 (thirty) days exactly in accordance with the terms and conditions illustrated in the CONTRACT. The bidders/tenderers shall, however, give specific date of their shortest guaranteed delivery period (in case different from that mentioned in tender documents/notice) by which the supply will be completed positively.
5. Tenders/bidders shall purchase separate tender documents and furnish cash receipt(s) for each alternate offer in case they want to submit alternate offer for any item(s). However, the choice to select/ignore any of the alternate offer(s) shall rest with the purchaser.
6. Free installation/demonstration of store at consignee's end shall be confirmed be the tenderer/bidder in his/her tender documents.
7. The supplier shall require to mention the exact and separate WARRANTY of the each and every item. Warranty of parts and service for 01 (one) year will at least be required with confirmation regarding availability of spare parts.
8. In case of Sole-distributor/Sole Agent, a certificate/authority letter in original from their PRINCIPAL(s) / ORIGINAL MANUFACTUREER (s) will be required to be provided by the tenderer/bidder to guarantee satisfactory performance, after sales services and availability of spare parts for item No. \_\_\_\_\_.
9. EARNEST MONEY:- All firms whether registered or un-registered will have to submit Earnest Money @ 2.5% of the value of their offer in the shape of Pay order / Call deposit / Bank deposit in the name of Deputy Director Estt: / Admn, Zulfikarabad Development Authority, Government of Sindh the offer(s)/rate(s) received without earnest money will not be entertained.
10. PERFORMANCE SECURITY: - The successful tenderers will have to deposit 8% as performance security with the purchaser. Security Deposit in the shape of Pay order / Call deposit / Bank deposit in the name of Deputy Director Estt: / Admn, Zulfikarabad Development Authority, Government of Sindh.
11. WARRANTY:- The Successful tenderer/bidder shall submit a warranty certificate to the effect that store supplied by them are brand new and absolutely

free from any material and manufacturing defect and strictly in conformity with the specifications as stipulated in tender enquiry with absolute guarantee that in case of any defect/deficiency, the stores are rejected at the time of final inspection by the technical Inspection Committee, the same shall be replace/substituted to the entire satisfaction of the consignee/Technical and Inspection Committee free of cost.

12. INSPECTION: - A joint inspection of stores will be made by the Director Estt: / Admn, Zulfikarabad Development Authority, Government of Sindh, and Director (Technical), Z.D.A before finalizing the procurement.
13. The purchaser reserves the right to increase or decrease the quantity and receive or reject any or all tenders without assigning any reason(s).
14. The tenderers/bidders shall enclose along with their tender following certificate failing which the tender is liable to be considered non-responsive.
