Information Technology Department, Government of Sindh (ITD), invites proposals from companies having a legal presence in Pakistan for implementation for "Introduction of e-Police System in Sindh" including Data Centre, IT Equipment, Networking and other necessary items. This system will be part of infrastructure to enable and extend enterprise resource planning and integrated information sharing portal over secure service. This Request for Proposal is being issued as part of the plan of the e-Police concepts and provides a basis for such enablement. This project aims to enhance the current IT infrastructure with Inter-connectivity at Police HQ & various other locations and Central Prison and districts prisons, so as to improve internal communications, facilitate speedy delivery of services to different departments and provide appropriate access to information on the workings.

Information Technology Department, Government of Sindh, invites Technical and Financial proposals (Separately sealed) for the above work under single stage-two envelopes bidding process, under SPPRA rules, 2010 from all qualified companies to implement this component on **TURN-KEY** basis solution.

3. Technical Proposals of the participating bidders will be opened in the same day (**2nd February 2012**) at **1.00 pm** in presence of the Committee of IT Department, Govt. of Sindh and intending bidders or their authorized representatives.
4. Pre-bid meeting would be held on **23rd January, 2012 at 2:00 p.m.** at the Committee Room of the Information Technology Department (as per Sr. No 2 above) in the presence of the Secretary / Director General Information Technology Department.
5. Financial bids of only technically qualified bidders shall be opened, subsequently in accordance with rules and procedure.
