- The tenders document will be issued to the Contractors/firms on submission of 2. application on their original letter head along with Pay Order of Tender Cost (nonrefundable) in favour of K.M.C. as mentioned above.
- The Bid Security as mentioned above in shape of pay order in favour of K.M.C. must be 3. enclosed with tender documents without which the tender will be treated as cancelled.
- The contractors must mention their complete and correct present postal address in 4. tender documents & quote the rates both in words & in figures. Incomplete/conditional tenders will not be accepted. The bidders must furnish the documentary evidence for eligibility as well as minimum qualification criteria as mentioned above. Otherwise their tender will be summarily rejected without consideration of their bid amount.
- In case of un-workable rate, KMC may ask the bidder to furnish performance guarantee 5. of an amount equal to 10% of estimated (Construction) cost as mentioned in the N.I.T. in shape of Pay Order or Bank Guarantee in favour of K.M.C. at the time of agreement, which will be released along with the Retention Money. In case of non-furnishing this additional performance guarantee, the bid security will be forfeited and other action including black listing will be taken as per rule.
- The procuring agency may reject all or any bids or proposals at any time prior to the 6 acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rule 2010.
- The condition of contract will also be available on K.M.C. web Site (www.karachicity 7.
- In case the opening date is declared as public holiday by the Government, the next 8 working day shall be deemed to be the date for submission and opening of tender.
