## NOTICE INVITING TENDER

Rules-33 and Rule-35 of the Public Procurement Regularity Authority (PPRA), Public Procurement Rules, 2004 provided as follows:

33. Rejection of bids:- (1) procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicated to any contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

(2). The procuring agency shall incur no liability, solely by virtue of its invoking sub-rule (1) towards contractors who have submitted bids or proposals

(3) Notice of the rejection of all bids or proposals shall be given promptly to all contractors that submitted bids or proposals.

35. Announcement of evaluation reports:- Procuring agencies shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract.
