Minutes of the Meeting of the Committee for purchase of Computers / I.T Equipment for Sindh University Campus, Dadu held on 17th January, 2012 at Committee Room, Planning & Development Cell, New Administration Block, University of Sindh, Jamshoro

The meeting started with the recitation of the Holy Quran by Asif Ali Khoro, Purchase & Store Officer, University of Sindh, Jamshoro. Prof. Dr. Anwer Ali Shah G. Syed, Pro-Vice Chancellor, Sindh University Dadu Campus & Convener of the Purchase Committee briefed the members about the orders of the Worthy Vice Chancellor regarding the purchase of the latest Computers / IT Equipments for Sindh University Dadu Campus.

The Purchase & Store Officer (PSO) informed that tenders as per SPPRA rules were invited last year i.e July, 2011 for computers. The committee observed that eight months already have passed, it will be appropriate to survey the current market rates of the computers & then decide about inviting new & fresh tenders. Prof. Dr. Imdad Ali Ismaili, Pro-Vice Chancellor, Sindh University Mirpurkhas Campus & Member / Expert of the committee surveyed the market through mobile phone. Beside PSO also called one dealer / supplier of the computer who apprised the new rates of Computers as per current market.

After considering the rates of the computers ascertained from the various sources, the committee recommends that in order to avail the benefit of the current market prices new tenders may be invited in the interest of the University of Sindh Dadu Campus by fulfilling the codal formalities, as the funds have been released by the Government of Sindh under the directives of the President of Pakistan.
