In accordance with Public Procurement Rule, 2010, the Inspector General of Prisons Sindh invites sealed Bids for supply of following best quality different kind of Yarn from the manufacturers, authorized dealers & suppliers duly registered with Sales Tax and Income Tax Department.

- 1) Interested manufacturers, authorized dealers & suppliers may obtain the Bid documents for the supplies of above mentioned different kind of Yarn from the office of Inspector General of Prisons Sindh Camp Office at Central Prison Karachi upto 14.03.2012 during office hours on payment of Rs.1500/- (in cash) by submitting application on their letter head alongwith valid and attested copies of Income Tax, Sales Tax Registration Certificate, Latest Professional Tax Certificate and computerized NIC.
- 2) All the bidders shall have to deposit earnest money at Rs.3% (refundable) of the estimated value of their offer in shape of Pay Order / Demand Draft in favour of Inspector General of Prisons Sindh Karachi drawn on any Branch of any schedule bank of Pakistan alongwith bid documents.
- 3) Sealed Tenders should reach Office of the Inspector General of Prisons Sindh Camp at Karachi by 15.03.2012 on 12.30 P.M which will be opened on the same day at 1.00 P.M in the presence of tenderers.
- 4) Samples of above articles tagged, singed, sealed and packed should accompany the tenders / tenderers. Non submission of samples will make the bidder ineligible / un-qualified.
- 5) The quantity of above mentioned yarn can be increased or decreased on approval of final rates.

- 6) Rate quoted must include Income Tax and other taxes according to Government rules.
- 7) Only bids offered on the prescribed Bid form issued by the Inspector General of Prisons Sindh shall be accepted. However additional sheets may be attached, if required.
- 8) The price so quoted in bid should be valid for full financial year ending 30th June 2012.
- 9) Each Bid shall comprise a single package containing two separate envelopes, each envelope shall contain separately (i) **Financial Proposal** (price / rate of the respective item) and (ii) **Technical Proposal** (specification of the respective item) and shall be marked in bold letters as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" respectively and should be dropped in the tender box kept in the office of undersigned by above mentioned date and time. Samples should however be delivered by hand alongwith duly typed list of the samples.
- 10) Technical Proposals will be opened on above mentioned date and time in presence of the bidders or their representatives present on the occasion.
- 11) Purchase Committee will scrutinize all the Technical Proposals and will finalize the list of qualified firms which are according to given specification.
- 12) Date of opening of the Financial Proposals will be announced later on. The proposal of only those companies / firms will consider which are declared qualified by the Purchase Committee.
- 13) Conditional Bid / application will not be entertained.
- 14) Supply must be completed according to clause of bid document and handed over on (D.D.P) destination at the office of undersigned.
- 15) Any further information needed, may be obtained from the office of Inspector General of Prisons Sindh Camp Office at Central Prison Karachi on any working day during office hours on phone No. 021-99231418, 99231084 and fax No. 021-99231418.
- 16) The competent authority reserves the right to reject any or all Bids in accordance with the SPPRA Rules, 2010.
