### INSTRUCTIONS:

1. Bidders may obtain Bidding Documents from the office of the undersigned upon payment of non-refundable cost as per above in the shape of Pay-Order/Bank Draft in favor of Project Director Shaheed Mohtarma Benazair Bhutto Accident, Emergency & Trauma Centre and Ancillary Services Complex at Civil Hospital Karachi.
2. Post-Qualification is open to authorized and reputable, sole distributors/dealers/agency holders/firms for lifts of U.S.A, Japan, Western Europe, or equivalent. Applicant's firm should be registered with Pakistan Engineering Council (PEC) in Category C-5 with field of specialization ME-03. Applications may be submitted for post-qualification for the above works.
3. The bidders shall visit the project site to be acquainted with the existing conditions and also to get familiar with the quantum of work and finishes with materials required for subject work. A joint visit to the project site can be arranged on request.
4. Pre-bid meeting will be held on 17-03-2012 in the Office of the Project Director Shaheed Mohtarma Benazair Bhutto Accident, Emergency & Trauma Centre and Ancillary Services Complex at Civil Hospital Karachi.

### BIDDING PROCEDURE:

1. Bids will be **Single Stage, two Envelopes Procedure**.
2. One Envelope will contain "**Technical Proposal**" of Elevators.
3. Second Envelope should contain "**Financial Proposal**" (Rate/Quoted Cost) alongwith Bid Security/Retention Money equivalent to 1% of the quoted cost in the shape of Pay-Order/Demand Draft (Refundable to the un-successful bidder after finalization of the case).

The Envelope must clearly marked as **“Financial Proposal”**.

4. Both envelopes (Technical & Financial) should be sealed separately and placed in third envelope. The name of bidder be marked clearly on all envelopes.
5. Tender containing Technical & Financial Proposals should be submitted on 11:00 a.m. on 22-03-2012 and will be opened on the same day at 11:30 a.m. in the Board Room situated at Second Floor of the Administration Block of Civil Hospital, Karachi in presence of **“Procurement Committee”** and bidders or their representatives who wish to attend.
6. The Technical Proposal will be evaluated and approved by the **“Procurement Committee”** for the above said job on the basis of Technical Proposals submitted by bidders.
7. The Procurement Committee shall open **“Financial Proposals”** of technically accepted/qualified bids only, in the Board Room situated at Second Floor of Administration Block of Civil Hospital, Karachi in presence of the bidders or their representatives.
8. The Financial Proposals of bidders, found technically non-responsive shall be returned un-opened to the bidders or their representatives.
9. The tenders which do not fulfill the terms and conditions of the Tender Documents will not be entertained.
