- 2. The tender documents will be issued to the contractor on submission of written request on letter head and on payment of non-refundable cost of tender price through pay order from any schedule Bank in favor of KMC on the date as given above. Bid Security in shape of pay order / bank guarantee from any schedule Bank in favor of KMC as mentioned above should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on the tender opening date.
- In case of any reason, if the tenders are not responded on the above ate the next date of submission and opening will be 28-03-2012 and the tender documents will be available for sale up to 27-03-2012.
- 4. In Case the date of opening or last date of sale is declared as a public holiday by the Government, or non-working day due to any reason, the next working day shall be deemed to be the date for last date of sale and submission and opening of tenders at the same time as mentioned above.
- The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction made by the contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.

# 6. Substantially Responsive Bid:-

Those bids which comply each requirement of minimum qualification criteria as provided in the Bidding Documents are only eligible for further detail evaluation. The bids which will not comply all the minimum qualification criteria will be liable to be summarily rejected.

- 7. The bidder is required to submit the above information, the signed evidence against evaluation criteria along with their bids. However, Joint venture between two or more firms is allowed subject to compliance of SPPRA / PEC's rules and regulation.
  - If any fake documents are found then the tender is liable to be rejected/cancelled with out any compensation and with penalty as per rules.
  - Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported canvassing will be liable for rejection.
  - 10. If a bidder submit a seriously unbalanced bid then if deemed necessary, the procuring agency may require him to deposit extra performance security to a level sufficient to protect the procuring agency against financial loses, failing which the submitted bid security will be forfeited by the procuring agency.

- 11. Bid Security of the unsuccessful bidder shall be released once the contract has been finalized with the successful bidder or the validity period has expired.
