 the presence of Tender opening committee and the bidder or their authorized representative
 who wish to be present.
- If due to unavoidable circumstances the undersigned is out of headquarter or in case the tenders are canceled /rejected, the next date for issuance and opening will be as under:
 - a) Issuance on 31st March and opening on 16th April 2012
 - b) Issuance on 18th April and opening on 2nd May 2012
- Eligibility conditions for intending participants in addition to TORs & Evaluation criteria are as under:
- a) Full name of the firm along with organizational structure and permanent address with telephone number, fax number and email.
- b) Details of work executed by the contractors in the past ten years indicating scope of work, estimated cost and time taken for completion duly certified by the concerned authorities.
- c) List and locations of equipments, transport machinery available with the contractor for this job.
- d) Affidavit that the contractor has neither been black listed by any agency with the firm /contractor for this project.
- e) Copy of fresh enlistment letter of Pakistan Engineering Council in C-A category & above only.
- Bio data of the technical staff permanently employed and available with the firm /contractor for this project.
- g) List of cases entered into arbitration /litigation. If not involved then affidavit to the effect that the firm /contractor was not involved in any litigation, no work was rescinded in the past.
- h) List of work where penalty is involved, if any.
- i) Income tax returns of last three years duly certified /verified.
- j) Professional Tax Certificate.
- k) Any additional information the applicant may like to furnish in support of his papers.

For qualification of the firms joint venture would not be considered and only lead firms will be considered, however the qualified firms will not be debarred for any joint venture in project execution with prior approval of project authorities.
- 6. Conditioned and telegraphic tenders will not be entertained.

- 8. The bidding will be single stage two envelope procedures. Technical & Financial Proposals in separate sealed envelopes clearly marked as a. Technical Proposal marked as "Do not open except in presence of Technical Committee" and b. Financial Proposal clearly marked "Do not open with Technical Proposal". Both Technical & Financial Proposals would further be sealed in an outer envelope clearly marked as "Technical & Financial Proposal" and addressed to "Project Director, Establishment of Anti Snake Venom / Anti Rabies Serology Laboratory in Sindh Old DHO Office Sakrand Road Shaheed Benazirabad".
