- (3) Both envelope (Technical and Financial) should be sealed separately and placed in a 3<sup>rd</sup> Envelope. The name of the bidder be clearly marked on all envelopes.

Tender should be dropped in the tender box kept in the office of the Sr. Director Medical Services K.M.C. @ 6<sup>th</sup> Floor Civic Center, Karachi **on above said date & time.**

The Technical Proposals of bids shall be opened publicly on **above said date & time** in presence of bidders or their nominated representatives who wish to attend.

After the evaluation and approval of the technical proposals for Purchase of Equipments/ Instruments/ Machinery/ Furniture & etc on the basis of **Documents/original Brochures etc**, the authority shall publicly open the **financial proposals of the technically accepted bids** only in the office of the Sr. Director Medical Services K.M.C. @ 6<sup>th</sup> Floor Civic Center, Karachi. **The financial proposal of bids found technically non-responsive shall be returned un-opened to the representative bidders.**
