SSCs must have the relevant experience and technical expertise in the fields (HEIS) for Planning, Surveying, Designing, Supplying, Installation and its operation and Maintenance.

SSCs must be registered under Company Act 1984 & with Income Tax and Sales Tax Department.

If firms do not supply the full information in accordance with requirement of TORs given in the RFP the proposals shall be considered as non responsive.

All the SSCs shall be scrutinized on the basis of their performance in the last three years. Only those companies will be eligible which can deliver the full package of planning, survey, designs, delivery of material, installation and two years post installation O&M services. Companies will be required to describe relevant previous work and give details of their manpower capacity technical expertise and relevant experience in HEIS.
