2. Initially, the technical proposals will be opened by the Tender Opening Committee on the date and time mentioned above, whereas the financial proposal will be retained with KMC till evaluation of the technical proposals.
3. In case, due to any reason, no tenders are received on the above dates then the next date of submission and opening will be 25-04-2012 and accordingly the tender documents will be available for sale upto 23-04-2012.
4. The technical proposals submitted by the bidders will be evaluated by Procurement Committee and thereafter financial proposals of technically qualified bids will be opened by the same Committee on the date and time to be communicated to the bidders.
5. The financial proposals of the bids found technically non-responsive shall be returned unopened to the respective bidders.
6. In case the date of opening or last date of sale is declared as a public holiday by the Government or non-working day due to any reason, the next working day shall be deemed to be the date for last date of sale and submission and opening of tenders accordingly. The time and venue shall remain the same.
7. The competent authority reserves the right to reject any or all proposals subject to the relevant provision of SPPRA Rules.
8. Canvassing in connection with tendering is strictly prohibited and proposals submitted by the contractors who are reported to be involved in canvassing are liable for rejection.
