- 4. The Bid Security as mentioned above in shape of pay order in favour of K.M.C shall must be enclosed with tender documents without which the tender will be treated as cancelled.
- 5. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will be not accepted. In addition, the bidders must furnish the documentary evidence against each eligibility criteria as mentioned above with there bid. Otherwise their tender will be summarily rejected without
- 6. The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This guarantee will be released after completion of work.
- 7. An amount equal to 5% from each bill will be deducted as Retention Money, which will be released after successful expiry of maintenance period.
- 8. The tender documents can be had from the office as mentioned above on any working day during office hours except the date of opening.
- 9. All the tender shall be dropped on as per above Schedule up to 02:00 p.m and will be opened by the Tender Opening Committee in the office of Superintending Engineer, DMC (Central) Karachi at 02:30 p.m in presence of the contractor who wish to be present.
