**NOTICE FOR HIRING OF PRIVATE STORAGE
ACCOMMODATION**

The Food Department Government of Sindh, (Mirpurkhas Region) urgently requires private storage accommodation at the Districts mentioned below for storage of wheat stocks. Interested parties are therefore requested to submit their offers with required rate of rent per Sq. Ft. in person OR through their Authorized Representatives in writing at the District Food Controller's office latest by 10th March, 2012.

The premises offered at the places will be inspected for its suitability / feasibility and the matter will be placed before the committee for necessary approval.

The other terms and conditions for hiring of private Godowns are listed below:-

- (i) The Godowns must not be situated in low lying / flood hit / water logged / non-environment friendly area and should have easy access to main metalled road.
- (ii) The Godowns must have provision of electricity and water.
- (iii) The Godowns capacity of a unit should be a minimum of 500 metric tons with roof height of at last 20 ft.
- (iv) There should be no electrical leakage in the roofs or walls and must be fit for air tight arrangements (fumigation).
- (v) Floor of Godowns must be at a raised level by not less than atleast 1 (one) Ft. above (compared to its surrounding areas).
- (vi) Floor and walls of the godowns should be plastered and pit free.
- (vii) To avoid long queues at the Godowns there should be enough room for maneuverability of vehicles (trolleys / trucks).
- (viii) From security point of view the Godowns space should have a boundary wall.
