- The tender documents will be issued to the firms on submission of application in their original letter head alongwith Pay Order of Tender Cost in favour of K.M.C as mentioned above.

- An amount equal to 5% from each bill will be deducted as Retention Money, which will be released after successful expiry of maintenance period.
